Charles Earl of Bradford the patron of the rectory - of the said parish of Wigan and with the consent of the Honourable and Reverend George Thomas Orlando Bridgeman the rector or incumbent of the said rectory of the parish of Wigan aforesaid, and as such rector or incumbent, the patron of the vicarage of the said new parish of Saint John the Evangelist, Abram, and also of the perpetual curacy of the said parochial cha-pelry of All Saints, Hindley (in testimony whereof they the said consenting parties have respectively signed and sealed this representation) we the said Ecclesiastical Commissioners for England humbly represent that it would in our opinion be expedient that all those contiguous portions of the said parish of Wigan and of the said new parish of Saint John the Evangelist, Abram, which are described in the schedule hereunder written all which portions together with the boundaries thereof are delineated and set forth on the map or plan here-unto annexed, should be united and formed into one consolidated chapelry for the said church of All Saints situate within the parochial chapelry of All Saints Hindley as aforesaid and that the same should be named 'The Consolidated Chapelry

of All Saints, Hindley." "We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration and to make such Order in respect thereto as to your Majesty in your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of All Saints Hindley, being :---

"All that portion of the parish of Wigan in the county of Lancaster and in the diocese of Chester, which is comprised within and is coextensive with the limits of that part of the parochial chapelry of All Saints Hindley which is not included within the limits of the particular district of Saint Peter Hindley or within the limits of the new parish of Saint John the Evangelist, Abram, both which said particular district and said new parish are within the original limits of the parish of Wigan aforesaid. And also all that contiguous portion of the said new parish of Saint John the Evangelist, Abram, which originally formed a part of the parochial chapelry of All Saints Hindley aforesaid. The said portion of the parochial chapelry of All Saints Hindley and the Hindley aforesaid. said portion of the said new parish of Saint John the Evangelist Abram which are above described, being (when taken together) bounded as follows, upon the west by the particular district of Saint Peter Hindley aforesaid upon the south-west by - that the remaining portion of the new parish of Saint John the Evangelist Abram which is not within the original limits of the parochial chapelry ³ of All Saints Hindley on the south-east by the parish of Leigh in the said county of Lancaster and in the diocese of Manchester on the northeast partly by the new parish of West Houghton in the last-named county and diocese and partly by the consolidated chapelry of Wingates in the same county and diocese and upon the north-west partly by the new parish of Haigh and Aspull and partly by the new parish of Ince in Makerfield which two last-named cures are both within the -- original limits of the parish of Wigan aforesaid."

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of your Majesty, chapter forty-nine; of the Act of the eleventh and twelfth years of your Majesty, chapter thirtyseven; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fiftyfive, have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint Paul situate at Leamington within the limits of the new parish of Saint Mary, Leamington Priors in the county of Warwick and in the diocese of Worcester.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Paul situate at Learnington as aforesaid.

"Now therefore, with the consent of the Right Reverend Henry Bishop of the said diocese of Worcester (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that part of the said new parish of Saint Mary Learnington Priors which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said Church of Saint Paul situate at Learnington as aforesaid, and that the same should be named 'The District Chapelry of Saint Paul, Learnington Priors.'

"And with the like consent of the said Henry Bishop of the said diocese of Worcester (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings and burials should be solemnized or performed at such church, and that the fees to be received in
