And whereas the Justices of the county of Cumberland, in Quarter Sessions assembled, have applied to me to the effect that an Order should be made directing that the time during which the killing, wounding, and taking of wild fowl, as defined by the said Act, is prohibited shall be varied in the county of Cumberland, so as to be from the 1st day of March to the 1st day of August in each year.

Now, therefore, I, the Right Honourable Richard Assheton Cross, one of Her Majesty's Principal Secretaries of State, in pursuance of the said Act, and on such application as aforesaid, hereby order as follows :---

The time during which the killing, wounding, and taking of wild fowl, as defined by the said Act, is prohibited, shall be varied in the county of Cumberland, so as to be from the 1st day of March to the 1st day of August in each year.
