(2.) Revolving Light on Penguin Island.

WHEREAS, by the terms of the Notification dred rupees, or for any amo No. 28, dated the 20th April, 1859, and by the multiple of one hundred rupees.

conditions of the Promissory Notes, dated the S1st May, 1859, bearing interest at five and a half per centum per annum, issued in accordance with that Notification, the said Promissory Notes may be paid off and discharged on or after the 1st day of May, 1879, on the expiration of a previous notice of three months, which notice may be first given on the 1st day of February, 1879; and whereas it is the present intention of the Governor-General in Council to give the said notice, and to pay off the said Notes on or about the dates aforesaid, H:s Excellency the Right Honourable the Governor-General in Council has resolved to raise a lcan of ten crores of rupees for this purpose in the following manner:—

First.—This loan shall be entitled "The Transfer Loan, 1879."
