of a district chapelry to the consecrated church of Saint Paul situate at Hemel Hempstead within the limits of the parish of Hemel Hempstead in the county of Hertford and in the diocese of Saint Albans.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Paul situate at Hemel Hempstead as aforesaid.

"Now, therefore, with the consent of the Right Reverend Thomas Legh Bishop of the said diocese of Saint Albans (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would in our opinion be expedient that all that part of the said parish of Hemel Hempstead which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Paul situate at Hemel Hempstead as aforesaid, and that the same should be named 'The District Chapelry of Saint Paul, Hemel Hempstead.'

"And with the like consent of the said Thomas Legh Bishop of the said diocese of Saint Albans (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings and burials should be solemnized or performed at such church, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of

"We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order with respect thereto as to your Majesty, in your Royal wisdom, shall seem meet."

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Paul, Hemel Hempstead, being:-

"All that part of the parish of Hemel Hempstead in the county of Hertford and in the diocese of Saint Albans wherein the present incumbent of such parish now possesses the exclusive cure of souls which is bounded on the east partly by the parish of Redbourn and partly by the new parish of Laverstock Green on the south partly by the last-named cure and partly by the new parish of Boxmoor all in the county and diocese aforesaid and upon all other sides that is to say on the west and on the north-west by an imaginary line commencing upon the boundary which divides the said new parish of Boxmoor from the parish of Hemel Hempstead aforesaid at a point a little to the west of the bridge which carries Infirmary-lane over the line of the Midland Railway where the said lane is joined by the public footpath leading towards High-street in the town of Hemel Hempstead and extending thence northward along the middle of the said footpath for a distance of twelve chains or thereabouts to its junction with a certain new road leading into High-street aforesaid and extending thence first northward and then north-westward along the middle of the said new road for a distance of eighteen chains or thereabouts

to its junction with High-street aforesaid and with Queen-street and extending thence eastward along the middle of the last-named street for a distance of seven chains or thereabouts to its junction with the alley or footway leading into George-street and extending thence northward along the middle of the said alley or footway for a distance of five and a half chains or thereabouts to its junction at the south-western corner of the buildings and premises called or known as the Hemel Hempstead National Schools, with the public footpath leading along the rear of the houses and premises situate on the southern side of George-street aforesaid into Redbourn-road and extending thence eastward along the middle of of the last-described public footpath for a distance of twelve chains or thereabouts to its junction with Redbourn-road aforesaid and extending thence northward along the middle of the last-named road for a distance of four chains or thereabouts to its junction with Saint Mary's-road and extending thence westward along the middle of the last-named road for a distance of ten chains and quarter or thereabouts to its junction with the alley or footway leading from George-street aforesaid into Chapel-street and extending thence north-ward along the middle of the last-described alley or footway for a distance of four chains or thereabouts (thereby passing the present western end of Herbert-street) to the junction of the same alley or footway with Chapel street aforesaid and continuing thence still northward across the last-named street to the middle of the southern end of the public footpath which leads in continuation of the said last-described alley or footway across the field called or known as the Sun Meadow into the street or road called or known as Cross-street otherwise Cherry Bounce Hill and continuing thence still northward along the middle of the last-described public footpath for a distance of six chains or thereabouts to its junction with Cross-street, otherwise called or known as Cherry Bounce Hill aforesaid and extending thence first eastward and then north-eastward along the middle of the last-named street or road for a distance of twenty-one chains or thereabouts to its junction with Redbourn-road aforesaid and continuing thence first north-eastward and then eastward along the middle of the last-named road for a distance of sixty-eight chains and a half or thereabouts to its junction with the road called or known as High-street Green and extending thence northward along the middle of the last-named road for a distance of six chains or thereabouts to its junction with the road leading to Redbourn and extending thence northeastward along the middle of the last-described road for a distance of seventy-six chains or thereabouts to the boundary at the intersection of the same road by the road leading from Holtsmore End to Westwick-row which boundary divides the said parish of Hemel Hempstead from the parish of Redbourn aforesaid."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Saint Albans.
