#### Thames Conservancy.—Bye-Laws.

**N**OTICE is hereby given, that the Conservators of the River Thames propose to make the following Bye-laws for the regulation and management of the river and the navigation thereof, as to tolls or annual payments in respect of pleasure-boats passing through, by, or over locks on the River Thames.

The Conservators of the River Thames in exercise of the power and authority vested in them by "The Thames Conservancy Acts, 1857 and 1864," "The Thames Navigation Act, 1866," "The Thames Conservancy Act, 1867," "The Thames Navigation Act, 1870," and "The Thames Conservancy Act, 1878," and of every other authority them thereunto in anywise enabling, do order and direct as follows, that is to say:—
