and Yorkshire Railway (Liverpool and Bury Branch aforesaid) to the point on the south-eastern side of the last-named branch line of railway a little to the south of the bridge which carries the same branch line of railway over the River Alt aforesaid where the said last-mentioned parish boundary joins the boundary dividing the said parish of Selton from the new parish of Saint Chad Kirkby aforesaid and extending thence first southward and then south-westward along the last-mentioned boundary for a distance of twentythree chains or thereabouts to the point on the south-eastern side of Sherwood's-lane a little to the south-west of Aintree-lane where the said last-mentioned boundary joins the boundary dividing the said new parish of Saint Chad Kirkby from the parish of Walton-on-the-Hill aforesaid and extending thence first south-eastward then south-westward and then again south-eastward along the last-mentioned boundary for a distance of thirty-six chains or thereabouts to the firstdescribed point on the south-eastern side of the house called or known as Elm Grove aforesaid in the middle of Long Moor-lane aforesaid at which point the said imaginary line commenced."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Chester.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the eighth and ninth years of Her Majesty, chapter seventy; of the Act of the fourteenth and fifteenth years of Her Majesty, chapter ninetyseven; of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five; of the Act of the thirty-fourth and thirty-fifth years of Her Majesty, chapter eighty-two; and of the Act of the thirty-fifth and thirty-sixth years of Her Majesty chapter fourteen; duly prepared and laid before Her Majesty in Council a representation, bearing date the eighth day of August in the year one thousand eight hundred and seventy-eight in the words following; that is to say :-

"We the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninih years of your Majesty, chapter seventy, of the Act of the fourteenth and fifteenth years of your Majesty, chapter ninety-seven, of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty - five, of the Act of the thirty-fourth and thirty-fifth years of your Majesty, chapter eighty-two and of the Act of the thirty-fifth and thirty-sixth years of your Majesty, chapter fourteen have prepared and now humbly lay before your Majesty in Council, the following representation as to the assignment of a consolidated chapelry to the consecrated church of All Saints, or known as Raven Brook and extending thence.

situate in or near to Bury-lane, in the parish of Newchurch, in the county of Lancaster and in the diocese of Chester.

"Whereas at certain extremities of the said parish of Newchurch, and of the new parish of Bedford in the said county of Lancaster, and in the diocese of Manchester which said extremities lie contiguous one to another, and are described in the schedule hereunder written there is collected together a population which is situate at a distance from the several churches of such parish and new parish respectively.

"And whereas it appears to us to be expedient that such contiguous portions of the said parish of Newchurch, and of the said new parish of Bedford, should be formed into a consolidated chapelry for all ecclesiastical purposes and that the same should be assigned to the said church of All Saints situate in or near to Bury-lane as afore-

"Now therefore, with the consent of the Right Reverend William Bishop of the said diocese of Chester, with the consent of the Right Reverend James Bishop of the said diocese of Manchester, with the consent of the Right Honourable Edward Henry Earl of Derby, the patron of the rectory of the said parish of Newchurch, and with the consent of the Reverend Joseph Heaton Stanning, Clerk in Holy Orders, the vicar or incumbent of the vicarage of the parish of Leigh in the said diocese of Manchester, the patron (in right of his incumbency) of the vicarage of the said new parish of Bedford (in testimony whereof they the said consenting parties have respectively signed and sealed this representation) we the said Ecclesiastical Commissioners for England, humbly represent that it would, in our opinion be expedient that all those contiguous portions of the said parish of Newchurch, and of the said new parish of Bedford which are described in the schedule hereunder written all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of All Saints situate in or near to Bury-lane as aforesaid, and that the same should be named 'The Consolidated Chapelry of All Saints, Glazebury,' and that such consolidated chapelry shall become and be and form part of the said diocese of Chester, and of the Rural Deanery of Winwick and of the Archdeaconry of Liverpool, within the same diocese.

"We therefore humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order in respect thereto as to your Majesty in your Royal wisdom shall seem meet.

"The Consolidated Chapelry of All Saints?

Glazebury, being :-"All that portion of the parish of Newchurch in the county of Lancaster and in the diocese of Chester which is bounded on the north partly by the new parish of Christ Church Pennington and. partly by the hereinafter described portion of the new parish of Bedford both in the said county of Lancaster and in the diocese of Manchester on the east by the aforesaid portion of the last-named new parish and upon the remaining sides that is to say on the south and on the west by an imaginary line commencing upon the boundary which divides the said new parish of Bedford from the parish of . Newchurch aforesaid at the point where the Glazebrook River is joined by the stream called
