ORDER of the Local Government Board : Rivers Pollution Prevention Act, 1876: "Tidal Waters" declared to be "Streams" under Sect. 20 :----

Local Government District of Caerleon.

- To the Guardians of the Poor of the Newport Union, in the counties of Monmouth and Glamorgan, being the Sanitary Authority for the Rural Sanitary District of that Union;
- To the Urban Sanitary Authority for the Urban Sanitary District of Caerleon, in the said county of Monmouth ; -

To the Usk and Ebbw Board of Conservators ;-And to all others whom it may concern.

WHEREAS by section 20 of the Rivers Pollution Prevention Act, 1876, it is declared that in that Act the word "stream" includes the sea to such extent, and tidal waters to such point, as may, after local inquiry and on sanitary grounds, be determined by the Local Government Board, by Order published in the London Gazette ; and that, save as aforesaid, it includes rivers, streams, cauals, lakes, and watercourses, other than watercourses at the passing of that Act mainly used as sewers, and emptying directly into the sea, or tidal waters which have not been determined to be streams within the meaning of that Act by such Order as aforesaid ;

And whereas application has been made to the Local Government Board by the Usk and Ebbw Board of Conservators to determine the tidal portions of the Afon Llwyd (being a tributary stream of the River Usk) and its tributaries, to be "streams" within the meaning of the Act above cited; and upon receipt of such application the Local Government Board directed local inquiry to be made on the subject, and such inquiry has been held, and a report has been made to them thereon :

Now therefore, we, the Local Government Board, in pursuance of the powers given to us by the above-recited section, do, by this our Order on sanitary grounds, determine that the tidal waters of the said Afon Llwyd and its tributaries, from the junction of the said Afon Llwyd and the River Usk upwards to every point in the said, Afon Llwyd or in any of its tributaries to which the highest tides rise, shall be deemed to be "streams" within the meaning of the Rivers Pollution Prevention Act, 1876.
