T the Court at Osborne House, Isle of Wight, the 4th day of February, 1879.

## PRESENT,

The QUEEN's Most Excellent Majesty. His Royal Highness Prince Leopold. Lord President. Marquis of Salisbury.

HEREAS by section 18 of "The Extradition Act, 1870," it is among other things enacted, that if by any Law made after the passing of the said Act by the Legislature of any British Possession, provision is made for carrying into effect within such spossession the surrender of fugitive criminals who are in, or suspected of being in, such British Possession, Her Majesty may, by the Order in Council applying the said Act in the case of any Foreign State, or by any subsequent Order, either-

Suspend the operation within any such British Possession of the said Act, or of any part thereof, so far as it relates to such Foreign State, and so long as such law continues in force there and no longer;

Or direct that such Law or Ordinance or any part thereof shall have effect in such British Possession, with or without modifications and alterations, as if it were part of the Act:

And whereas by an Act enacted by the Legislature of Bermuda, the short title of which is, "The Extradition Act, Bermuda, 1877," it is provided that "all powers vested in and acts authorized or required to be done by a Police Magistrate or any Justice of the Peace in relation to the surrender of fugitive criminals in the United Kingdom under 'The Extradition Acts, 1870 and 1873,' are thereby vested in and may in the Colony be exercised and done by any Police Magistrate in relation to the surrender of fugitive Criminals under the said Acts":

And whereas it is further provided by the said Act that the said Act shall not come into operation until Her Majesty shall, by Order in Council, direct that the said Act shall have effect within the Colony as if it were part of the "Extradition Act, 1870," but that the said Act shall thereafter come into operation as soon as such Order in Council shall have been publicly made known in the Colony.

Now, therefore, Her Majesty, in pursuance of "And whereas it has been made to appear that "The Extradition Act, 1870," and in exercise of the increase to the said establishment has, in purthe power in that behalf in the said Act contained, suance of "The: Merchant: Shipping Act, 1854,"

doth by this present Order, by and with the advice of Her Majesty's Privy Council, direct that the said Extradition Act, Bermuda, 1877, shall have effect in the Colony of Bermuda, without modification or alteration, as if it were part of "The Extradition Act, 1870."

And the Right Honourable Sir Michael Edward Hicks-Beach, Bart., one of Her Majesty's Principal Secretaries of State, is to give the necessary directions herein accordingly.

## PRESENT,

The QUEEN's Most Excellent Majesty in Council.

HEREAS by the 420th section of "The Merchant Shipping Act, 1854," it was enacted that Her Majesty might from time to time, by and with the advice of Her Privy Council, fix the establishment to be maintained by each of the General Lighthouse Authorities on account of the services of lighthouses, buoys, beacons, or the annual or other sums to be paid out of the Mercantile Marine Fund in respect of such establish -: ments; and that no increase of any establishment. or part of an establishment so fixed should be made without the consent of the Board of Trade:

And whereas by an Order in Council dated the fourth day of February, eighteen hundred and seventy-five, Her Majesty was pleased, in exercise of the power vested in Her by the said Act, to fix the establishments which might be maintained by the Corporation of Trinity House of Deptford Strond (hereinafter called the Corporation) the Commissioners of Northern Lighthouses and the Commissioners of Irish Lights, the establishment to be thenceforth maintained by the Corporation being set forth in the schedule marked A, annexed to the said Order:

And whereas with a view to an improved organization of the Engineering Staff of the Corporation, it is expedient that the establishment by the said Order fixed to be maintained by them as aforesaid should be increased in manner hereinafter appearing:
