Now, therefore, Her Majesty, by virtue and in exercise of the power vested in Her by the said Act, by and with the advice of Her Privy Council, is pleased to direct, and doth hereby direct, that in addition to the establishment fixed by the above-named Order, and set forth in the schedule thereto, marked A, the following shall be maintained by the Corporation ; namely :—

As Engineer-in-Chief, Mr. James Nicholas Douglass, at a salary of fifteen hundred pounds per annum from the twenty-sixth December, 1877, rising by increases of one hundred pounds per annum to a maximum of eighteen hundred pounds per annum :

As Assistant Engineer, Mr. Arthur Ayres, at a salary of four hundred and sixty pounds per annum from the twenty-fifth June, 1878, rising by increases of twenty pounds per annum to a maximum of six hundred pounds per annum :

As Chief Engineering Clerk, Mr. Thomas Williams at a salary of three hundred pounds per annum from the twenty-fifth June, 1878, rising by increases of ten pounds per annum to a maximum of four hundred pounds per annum :

but the said salaries may, with the consent of the Board of Trade, be increased beyond the minimum, provided they do not exceed the maximum, amounts named above.

And Her Majesty, by virtue and in further exercise of the power vested in Her as aforesaid, by and with the advice aforesaid, doth hereby direct that the said salaries shall be paid out of the Mercantile Marine Fund, and shall be regarded as strictly personal to the three gentleman above named.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the eighth and ninth years of Her Majesty, chapter seventy; of the Act of the fourteenth and fifteenth years of Her Majesty, chapter ninety-seven; of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five; and of the Act of the thirty-fourth and thirty-fifth years of Her Majesty, chapter eighty-two; duly prepared and laid before Her Majesty in Council a representation, bearing date the twenty-eighth day of November in the year one thousand eight hundred and seventy-eight in the words and figures following; that is to say:—

“We the Ecclesiastical Commissioners for England in pursuance of the Act of the eighth and ninth years of your Majesty chapter seventy, of the Act of the fourteenth and fifteenth years of your Majesty, chapter ninety-seven, of the Act of the nineteenth and twentieth years of your Majesty chapter fifty-five and of the Act of the thirty-fourth and thirty-fifth years of your Majesty chapter eighty-two have prepared and now humbly lay before your Majesty in Council the following representation as to the assignment of a consolidated chapelry to the consecrated church of the Holy Trinity situate at Harrow Green in the district

parish of Leytonstone in the county of Essex and in the diocese of Saint Albans.

“Whereas at certain extremities of the said district parish of Leytonstone and of the parish of Leyton, of the parish of Wanstead, of the parish of West Ham and of the new parish of Saint Paul Stratford New Town, all in the said county of Essex and in the said diocese of Saint Albans which said extremities lie contiguous one to another and are described in the schedule hereunder written there is collected together a population which is situate at a distance from the several churches of such respective cures.

“And whereas it appears to us to be expedient that such contiguous portions of the said district parish of Leytonstone, of the said parish of Leyton, of the said parish of Wanstead, of the said parish of West Ham, and of the said new parish of Saint Paul Stratford New Town, should be formed into a consolidated chapelry for all ecclesiastical purposes and that the same should be assigned to the said church of the Holy Trinity situate at Harrow Green as aforesaid.

“Now therefore with the consent of the Right Reverend Thomas Legh, Bishop of the said diocese of Saint Albans as such Bishop and also as the patron in right of his see of the vicarage of the said district parish of Leytonstone with the consent of the Reverend Edward Jones Brewster Clerk in Holy Orders the vicar or incumbent of the vicarage of the said parish of Leyton as the patron of the same vicarage with the consent of the Honourable Francis Leveson Bertie of 12 Stratton-street in the county of Middlesex and of Andrew Alfred Collyer-Bristow of 4 Bedford-row in the county of Middlesex Esquire (upon the nomination of the Right Honourable Henry Richard Charles Earl Cowley Knight of the Most Noble Order of the Garter) and with the consent also of the same Henry Richard Charles Earl Cowley as the patrons of the rectory of the said parish of Wanstead with the consent of the Right Honourable Benjamin Earl of Beaconsfield Knight of the Most Noble Order of the Garter First Lord of Your Majesty's Treasury as the patron on behalf of the Crown, of the vicarage of the said parish of West Ham and with the consent of Thomas Fowell Buxton of Brick-lane Spitalfields in the county of Middlesex Esquire of the Reverend Able John Ram Clerk in Holy Orders the rector or incumbent of the rectory of the parish of Rolleston in the diocese of Lichfield of the Reverend William John Crichton of Eaton-place in the said county of Middlesex Clerk in Holy Orders, of Raymond Pelly of Hollington Saint Leonards on Sea in the county of Sussex Esquire and of Thomas Henry Griffith of the Inner Temple in the said county of Middlesex Barrister at Law as the patrons of the vicarage of the said new parish of Saint Paul Stratford New Town (in testimony whereof they the said consenting parties have respectively signed and sealed this representation) we the said Ecclesiastical Commissioners for England humbly represent that it would in our opinion be expedient that all those contiguous portions of the said district parish of Leytonstone, of the said parish of Leyton, of the said parish of Wanstead, of the said parish of West Ham, and of the said new parish of Saint Paul Stratford New Town, which are described in the schedule hereunder written all which portions together with the boundaries thereof are delineated and set forth on the map or plan hereunto annexed should be united and formed into one consolidated chapelry for the said church of the Holy Trinity situate at Harrow Green as aforesaid, and that the same should be named ‘The Consolidated Chapelry of the Holy Trinity Harrow Green Leytonstone.’
