## THE HIGH COURT OF JUSTICE.—CHANCERY DIVISION.

THE Lords Commissioners of Her Majesty's Treasury, with the concurrence of the Lord Chancellor, and in exercise of the powers for this purpose given by the 14th section of "The Courts of Justice (Salaries and Funds) Act, 1869," and of every other power or authority enabling them in this behalf, do determine and order that, as from the 1st day of January, 1879, there be paid to William John Wood and William Powell Williams, two of the Junior Clerks in the Chambers of the Vice-Chancellor Sir Richard Malins. in addition to their present respective salaries of £500 per annum, the salary of £100 per annum each, and that as from such 1st day of January, 1879, there be paid also to Harry Grooby Rogers, another of the Junior Clerks in the Chambers of the said Vice-Chancellor, in addition to his present salary of £480; so long as it shall remain at that sum, and in addition to his maximum salary of £500, when he shall be entitled to such maximum, the salary of £100 per annum, and that such additional salaries be continued to them so long as they shall respectively discharge the higher duties now required of them, in addition to the duties usually devolving on Junior Clerks in the said Chambers, but that if in consequence of any other arrangement, such additional salaries be
