FACTORY AND WORKSHOP ACT, 1878. 41 Vict., c. 16, ss. 26, 95, 96.

Order of Secretary of State prescribing, with consent of Education Department, Standard of

Proficiency and Standards of previous due Attendance at School (England and Wales).

WHEREAS by the Factory and Workshop Act, 1878, it is enacted as follows :-

26. When a child of the age of thirteen years has obtained from a person authorized by the Education Department a certificate of having attained such standard of proficiency in reading, writing, and arithmetic, or such standard of previous due attendance at a certified efficient school, as hereinafter mentioned, that child shall be deemed to be a young person for the purposes of this Act.

The standard of proficiency and due attendance for the purposes of this section shall be such as may be from time to time fixed for the purposes
