TUNSTALL "WAKES" FAIR.

IN pursuance of the above-mentioned Act, I, the Right Honourable Richard Assheton Cross, one of Her Majesty's Principal Secretaries of State, hereby notify as follows:

1. By Memorial, dated the 20th day of May, 1879, a representation has been duly made to me by the Local Board of Health for the district of Tunstall, Staffordshire, as owners, that a Fair has been annually held on the Saturday before the third Sunday in July, and continued on the Sunday, Monday, and Tuesday next following, in the district of Tunstall, in the county of Stafford, and that it would be for the convenience and advantage of the public that such Fair should be abolished:

2. On the 30th day of June, 1879, I shall take the aforesaid representation into consideration, and all persons are to intimate, before that day, any objection they may desire to offer to the abolition of the said Fair.
