THE Lords of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. This Order shall take effect from and immediately after the sixteenth day of June, one thou-

sand eight hundred and seventy-nine.

2. So much of the area declared, by Order of Council dated the fifth day of March, one thousand eight hundred and seventy-nine, to be an area infected with pleuro-pneumonia as is in the county of Lanark is hereby declared to be free from pleuro-pneumonia, and that portion of that area shall, as from the commencement of this Order, cease to be an area or part of an area infected with pleuro-pueumonia.

3. The rest of the area comprised in the said Order shall continue to be and is hereby declared to be an area infected with pleuro-pneumonia, wherein the following place being a place infected with pleuro-pneumonia is situate (namely):

A cow-shed or byre, in the occupation of Robert Black, Dairyman, and situate at 14, Rutland-crescent, in the parish of Govan, in the C. L. Feel. county of Renfrew.

And to command that the said Royal concession and declaration be recorded in Her Majesty's said College of Arms.

THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Notice issued by the Greek Government, from which it appears that, although the quarantine of 24 hours imposed in Greece on arrivals from the Sea of Azov and the Black Sea, including Sulina, has been withdrawn, pratique is only granted to vessels after the visit of a medical officer; and that the importation of rags from the above places and from Turkey in general is still prohibited.

THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Notice issued by the Italian Government, respecting the importation of rags, old clothes, and unwashed linen from Greece, of which the enclosed is a translation; viz.:-

ORDINANCE OF MARITIME HEALTH. No. 14. In view of the law relating to the public health of the 20th of March, 1865, Clause C, and the

Ministerial Instructions of the 26th of December, 1871, and in view of the Ordinance of the 29th

of April, 1878, No. 6.

Considering that the Greek Government has imposed a prohibition, which it causes to be rigorously observed on the importation of rags, old clothes, and unwashed linen from Turkey and from the Russian Ports of the Black Sea and Sea of Azoff. The Minister of the Interior decrees:

That the aforesaid Ordinance of the 29th of April, 1878, is revoked as regards rags, old clothes, and unwashed linen imported from Greece,
