John Richard Baldwin Clerk in Holy Orders vicar or incumbent of the said vicarage of the parish of Dewsbury and as such vicar or incumbent the patron both of the vicarage of the said new parish of Saint Paul Hanging Heaton and of the vicarage of the said new parish of Saint Peter Earls Heaton (in testimony whereof they the said consenting parties have respectively signed and sealed this representation) we, the said Eccle-siastical Commissioners for England, humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said parish of Dewsbury of the said new parish of Saint Paul Hanging Heaton, and of the said new parish of Saint Peter Earls Heaton which are described in the schedule hereunder written, all which portions together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed should be united and formed into one consolidated chapelry for the said church of Saint Philip situate in Leeds-road in the parish of Dewsbury as aforesaid and that the same should be named 'The Consolidated Chapelry of Saint Philip Dewsbury.

"We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration and to make such Order in respect thereto as to your Majesty, in your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Philip Dewsbury, being :---

"All that portion of the parish of Dewsbury in the county of York and in the diocese of Ripon wherein the present incumbent of such parish now possesses the exclusive cure of souls and also all those contiguous portions of the new parish of Saint Paul Hanging Heaton and of the new parish of Saint Peter Earls Heaton both in the county and diocese aforesaid which said portions of such cures are comprised within and are bounded by an imaginary line commencing at the point where the boundary dividing the said parish of Dewsbury from the new parish of Saint Peter Earls Heaton aforesaid crosses the middle of Wakefield Old-road a little to the east of its junction with Wakefieldroad and extending thence first south-eastward and then north-eastward along the middle of the said Wakefield Old-road for a distance of twenty-one and a half chains or thereabouts to its junction with Sugar-lane and extending thence first northwestward and then northward along the middle of the said lane for a distance of twenty-five and a half chains or thereabouts (thereby crossing at the south-eastern end of the said lane the boundary which divides the said new parish of Saint Peter Earls Heaton from the new parish of Saint Paul Hanging Heaton aforesaid) to the junction of the same lane with the Leeds-road and extending thence north-eastward along the middle of the last-named road for a distance of exactly forty yards to a point opposite to a boundary-stone inscribed 'D. St. P. C. C. 1879 No. 1' and placed on the north-western side of the same road and extending thence that is from the middle of the said road in a direction due north-westward and in a straight line for a distance of seventy yards or thereabouts (thereby touching and passing the said boundarystone) to the north-castern boundary of Caulms Wood and continuing thence still north-westward along the said north-castern houndary of the said wood for a distance of ninetcen chains or thereabouts, (thereby passing along the upper edge of the cliff) to the point where the same boundary bends sharply towards the north and continuing

thence that is from the said boundary still northwestward and in a direct line for a distance of sixty-two yards or thereabouts across the said Caulms Wood to a boundary-stone inscribed D. St. P. C. C. 1879 No. 2' and placed on the western side of the same wood at or near to the point where the footpath leading from the Leedsroad aforesaid through the said wood to the house called or known as the Closes is joined by the footpath leading from the same wood into Crackenedge-lane and extending thence that is from the last described boundary-stone south-west-ward along the middle of the last-described footpath for a distance of eight and three-quarter chains or thereabouts to a point upon the boun-dary which divides the said new parish of Saint Paul Hanging Heaton from the parish of Dewsbury aforesaid and extending thence first northwestward then northward and then westward along the last-mentioned boundary for a distance of five and a half chains or thereabouts to its junction in the middle of Crackenedge-lane with the boundary which divides the said parish of Dewsbury from the new parish of Bailey Carr in the county and diocese aforesaid and extending thence southward along the last-mentioned boundary for a distance of seven and a half chains or thereabouts (thereby following the middle of the last-named lane) to the point where the same boundary diverges from the said lane in a southwesterly direction and continuing thence still generally southward along the middle of the same lane for a distance of twenty-three and a half chains or thercabouts to the Market-place in the town of Dewsbury and continuing thence still southward along the middle of the roadway on the eastern side of the said Market-place for a distance of two chains or thereabouts to the point where the said Market-place is joined by Wakefieldroad aforesaid and by Railway-street and extending thence south-eastward along the middle of the last-named street for a distance of five chains or thereabouts to its junction with Rishworth-street and extending thence north-eastward along the middle of the last-named street for a distance of one and a half chains or thereabouts to its junction with Rishworth-road and extending thence eastward along the middle of the last-named road for a distance of seven and a half chains or thereabouts to its junction with Ridings-road and extending thence south-eastward along the middle of the last-named road for a distance of one and a quarter chains or thereabouts to the boundary which divides the said parish of Dewsbury from the new parish of Saint Peter Earls Heaton aforesaid and extending thence first north-eastward and then eastward along the last-mentioned boundary for a distance of four chains or thereabouts to the first-described point in the middle of the Wakefield Old-road aforesaid where the said imaginary line commenced."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts : and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Ripon.
