And whereas at a Meeting of the Vestry of the said parish, held at the Vestry Room, pursuant to public notice in that behalf, on Tuesday, the 15th day of April, 1879, it was resolved, --"That the Local Government Board be

" requested to issue an Order under their " Seal of Office, directing that the Act passed " on the 5th August, 1850 (13 and 14 Vict., "c. 57), entitled 'An Act to prevent the " holding of Vestry or other Meetings in " 'Churches, and for regulating the appoint-"' ment of Vestry Clerks,' shall be applied " to and put in force within this parish, as " regards that portion of it which relates to
