The QUEEN's Most Excellent Majesty in Council. WHEREAS the Right Honourable Richard VV Assheton Cross, one of Her Majesty's Principal Secretaries of State, after giving to the Incumbents and the Churchwardens of the parishes hereinafter mentioned ten days' previous notice of his intention to make such representation, has, under the provisions of an Act passed in the session of Parliament held in the sixteenth and seventeenth years of Her Majesty's reign, intituled "An Act to amend the laws concerning the burial " of the dead in England beyond the limits of the "Metropolis, and to amend the Act concerning "the burial of the dead in the Metropolis," made a representation stating that, for the protection of the public health, no new burial ground should be opened in the undermentioned parishes without the previous consent of one of Her Majesty's Principal Secretaries of State, and that burials should be discontinued therein as follows, viz.:—

Shotwick.—Forthwith wholly in the Primitive Methodist Burial-ground, at Great Saughall, Shotwick, except so far as is compatible with the observance of the regulations for new

burial-grounds.

Congressury.—Forthwith wholly in the parish church of Congresbury, in the county of Somerset; and in the churchyard except in walled graves, every coffin buried in which shall be separately enclosed by stonework or brickwork properly cemented; and except in earthen graves which can be opened without the disturbance of offensive soil or of undecayed remains.

BEDMINSTER.—Forthwith wholly in the parish church of Saint Paul's, Bedminster, Bristol; and in the churchyard, except in vaults and walled graves, every coffin buried in which shall be separately enclosed by stonework or

brickwork properly cemented.

Wollaton.—Forthwith wholly in Wollaton Church, in the county of Nottingham; and in the churchyard, except in existing vaults, every coffin buried in which shall be separately enclosed by stonework or brickwork properly cemented.

ABERGELE.—Forthwith wholly in the parish church of Abergele, in the county of Denbigh; and in the churchyard after the thirtieth June, one thousand eight hundred and eighty, except in now existing vaults and walled graves, every coffin buried in which shall be separately enclosed by stonework or brickwork properly cemented; and except in earthen graves which can be opened without

the exposure of coffins or of undecayed remains.

Burron Joyce.—Forthwith wholly in the parish church of Burton Joyce, in the county of Nottingham; and in the churchyard, except in vaults and walled graves, every coffin buried in which shall be separately enclosed by stonework or brickwork properly cemented; and except in earthen graves which can be opened without the exposure of coffins or of undecayed remains.

FOREST ROW, EAST GRINSTEAD.—Forthwith wholly in Bethesda Chapel and chapelyard, Forest Row, in the parish of East Grinstead,

in the county of Sussex.

PENDLETON.—Forthwith wholly in the burialground of the Brunswick Wesleyan Chapel, Pendleton, in the parish of Eccles, in the

county of Lancaster.

Syston.—Forthwith wholly in the parish church of Syston, in the county of Leicester; and in the churchyard, except in existing vaults and walled graves, every coffin buried in which shall be separately enclosed by stonework or brickwork properly cemented; and except in earthen graves which can be opened without the exposure of coffins to the depth of four feet.

HOLY TRINITY, MAIDSTONE.—Forthwith wholly in the burial-ground adjoining Holy Trinity Church, Maidstone, in the county of Kent, except in now existing vaults and walled graves, every coffin buried in which shall be separately enclosed by stonework or brick-

work properly cemented.

TAXAL.—In the burial-ground adjoining the Spring Bank Chapel, Whaley Bridge, in the the county of Chester, except in existing family graves which can be opened without the exposure of coffins.

GATE HELMSLEY.—Forthwith wholly in the old part of Gate Helmsley Churchyard, in the

county of York.

LLANGADOCK.—Forthwith wholly in Llangadock Vawr Church, in the county of Carmarthen; and in the churchyard after the thirtyfirst March, one thousand eight hundred and
eighty, except in now existing vaults and
walled graves which are free from water,
every coffin buried in which shall be separately enclosed by stonework or brickwork
properly cemented; and except in earthen
graves which are free from water for the
burial of the widowers, widows, and unmarried
children of those already buried therein.

WARTHILL.—Forthwith wholly in the old part of Warthill Churchyard, in the county of

York

BONCHURCH, ISLE OF WIGHT.—Forthwith wholly in the old parish church of Bonchurch, Isle of Wight, in the county of Hants; and in the churchyard, except in existing family vaults and graves.

BURGHCLERE.—Forthwith wholly in the parish church of All Saints, Burghclere, in the county of Hants; and in the churchyard, except in existing vaults and walled graves, every coffin buried in which shall be separately enclosed by stonework or brickwork properly cemented.
