THE following Despatch, with its Enclosures, has been received from the Right Honourable Sir Bartle Frere, Bart., G.C.B., Governor of the Cape Colony :-

SIR, October 1, 1879. I HAVE the honour to transmit the return of casualties in the colonial forces during the month of August last,

Return of Casualties which have occurred in the Auxiliary Forces of the Cape of Good Hope between the 1st August and 31st August, 1879.

Private Sinta Sinta, Herschel Fingo Levy, died 6th August, through gun-shot wound, 30th July, Morosi's Mountain, Basutoland.

- Private P. Ferreira, 1st C.M.Y., died 25th August, from result of mortification of wounds ; wounded 29th May; attack on outpost at junction of Quiltring and Orange Rivers, Basutoland.
- Private Klaas Jordaan, 1st Stockenstrom Rifles, killed August 16th, attack on commissariat waggons at outspan, Basutoland.

Private Pretorius, No. 2 Company Stockenstrom Contingent, killed, 30th August, attack on Muntyao's Cave, Quiltring River, Basutoland.

FER Majesty in Council was this day pleased, on a representation of the Right Honourable the Lords of the Committee of Council on Education, to appoint Samuel Robertshaw Wilson, Esquire, B.A., Fellow of Sidney Sussex College, Cambridge, to be one of Her Majesty's Inspectors of Schools.

#### PRESENT.

The QUEEN's Most Excellent Majesty in Council.

HEREAS by the Merchant Shipping Act, 1876, it is enacted that when the Legislature of any British Possession provides for the survey of and grant of certificates for passenger steamers, and the Board of Trade report to Her Majesty that they are satisfied that the certificates are to the like effect, and are granted after alike survey, and in such manner as to be equally efficient with the certificates granted for the same purpose in the United Kingdom under the Acts relating to Merchant Shipping, it shall be lawful for Her Majesty by Order in Council-

- 1. To declare that the said certificates shall be of the same force as if they had been granted under the said Acts ; and
- 2. To declare that all or any of the provisions of the said Acts which relate to certificates granted for passenger steamers under those Acts shall, either without modification or with such modifications as to Her Majesty may seem necessary, apply to the certificates referred to in the Order ; and
- 3. To impose such conditions and to make such regulations with respect to the said certificates and to the use, delivery, and cancellation thereof as to Her Majesty may seem fit, and to impose penalties not exceeding fifty pounds for the breach of such conditions and regulations.

And whereas the Legislature of the British Possession of Bombay has provided for the survey of and grant of certificates for passenger steamers.

And whereas the Board of Trade have reported to Her Majesty that they are satisfied that such certificates are to the like effect and are granted after a like survey and in such manner as to be equally efficient with the certificates granted for the same purpose in the United Kingdom under the Acts relating to Merchant Shipping.

Now, therefore, Her Majesty is hereby pleased, by and with the advice of Her Privy Council-

1. To declare that the certificates granted under the said provision by the Legislature of the British Possession of Bombay for passenger steamers shall be of the same force as if they had been granted for the same purpose in the United Kingdom under the said Acts relating to Merchant Shipping.
