2. To declare that all the provisions of the said Acts which relate to certificates granted for passenger steamers under those Acts shall, without modification, except as hereinafter mentioned, apply to the certificates referred to in this Order.

3. To declare that it shall not be lawful for a passenger steamer to which this Order relates to proceed to sea with passengers on board from any port or place in the United Kingdom on any voyage other than one to the said Possession of Bombay or to any intermediate place or places situate on such

4. To declare that if any passenger steamer goes to sea from any place in the United Kingdom with any passengers on board upon any voyage other than a voyage to the said Possession of Bombay or any intermediate place or places as aforesaid the owner thereof shall for every such offence incur a penalty not exceeding fifty pounds, and such penalty is hereby imposed accordingly.

HEREAS by an Act passed in the Session of Parliament held in the eighteenth and nineteenth years of Her Majesty's reign, intituled "An Act further to amend the laws concerning "the burial of the dead in England," it is, amongst other things, enacted that it shall be lawful for Her Majesty, by and with the advice of Her Privy Council, from time to time, to postpone the time appointed by any Order in Council for the discontinuance of burials, or otherwise to vary any Order in Council made under any of the Acts recited in the said Act, or under the said Act (whether the time thereby appointed for the discontinuance of burials thereunder, or other operation of such Order, shall or shall not have arrived), as to Her Majesty, with such advice as aforesaid, may seem fit:

And whereas Orders in Council have been made directing the discontinuance of burials in the churchyards hereinafter mentioned from the time specified in such Orders; and whereas it seems fit to Her Majesty, by and with the advice of Her Privy Council, that the time for discontinuing burials in the said churchyards be post-

Now, therefore, Her Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered, that the time for the discontinuance of burials in such churchyards be postponed as follows; .viz.:-

In the parish churchyard of Stratford-on-Avon, in the county of Warwick, to the thirtieth of September, one thousand eight hundred and

In Belgrave churchyard, in the county of Leicester, to the first of July, one thousand

eight hundred and eighty.

In the churchyard of Great Bowden, in the county of Leicester, to the thirtieth of November, one thousand eight hundred and seventy-nine.

In the churchyard of St. John, Sheffield, to the thirtieth of June, one thousand eight hundred and eighty, on condition that the restrictions contained in that part of the Order in Council of the fourth of November, one thousand i eight hundred and sixty-seven, relating to that churchyard, be observed.
