- SAWSTON Forthwith wholly in Sawston Church, in the county of Cambridge ; and in the churchyard, except in vaults and walled. graves, every coffin buried in which shall be separately enclosed by stonework or brickwork properly cemented; and except in earthen graves, which can be opened to the depth of five feet without the exposure of coffins or the disturbance of offensive remains.

Now, therefore, Her Majesty in Council is pleased hereby to give notice of such representation, and to order that the same be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council on the

fifteenth day of January next: And Her Majesty is further pleased to direct that this Order be forthwith published in the London Gazette; and that copies thereof be affixed on the doors of the churches or chapels of, or on some conspicuous places within, the parishes affected by such representation one month before the said fifteenth day of January.
