(41 and 42 Victoria, chapter 77). Highways Declared Main Roads. Provisional Orders.

Ordered,—That, pursuant to the Act 41 and 42 Vic., cap. 77, sec. 15, the following ex-turnpike roads, disturnpiked prior to the 31st day of December, 1870, be, and they are hereby, declared Main Roads from the 25th day of March next, such roads having been inspected by the County Surveyor, and the Court being satisfied that they

ought to be Main Roads, viz.:—
1.—Wearmouth to Tyne Bridge Road, with branch to South Shields, except so much thereof as is in the district of the Felling Urban Sanitary

Board.

- 2. Shields-road, White Mere Pool to Jarrow Slake, and thence to East Boldon, except so much thereof as is within the detached portion of the district of the Southwick Urban Sanitary Board, and in the detached portion of the township of Monkwearmouth, both in the parish of Monkwearmouth.
- 3. Durham and Sunderland-road, except so much thereof as is within the city of Durham.

Durham and Shotley Bridge-road.

5. Corbridge and West Auckland-road, except so much thereof as is within the district of the Weardale Highway Board, south-east of the boundary of the Tow Law Local Board District, and so much thereof as is within the townships or parishes of Medomsley, Iveston, or Ebchester.

6. Bowes and Sunderland Bridge-road.

7. Lobley Hill-road, that portion situated in the town of Wolsingham, and which, since the expiration of the trust, has been repaired by the township of Wolsingham.

Also ordered, that the following road be and the same is hereby declared a main road, from the

said 25th day of March next, viz.:-

Road from Norton Bridge to south end of the village of Norton, to join the end of the present main road, Norton to Bishopwearmouth. Length, about .66 of a mile.

And further Ordered, that in accordance with the provisions of the said Act copies of the lastmentioned Provisional Orders be deposited at the office of the Clerk of the Peace, and open to the inspection of persons interested at all reasonable hours. And it is likewise hereby ordered and appointed that at the next General Quarter Sessions, to be holden at the Assize Courts, in the city of Durham, on Monday, the fifth day of April now next ensuing, the confirmation of the said last-mentioned Provisional Orders by Final Orders shall be taken into consideration.

Gateshead and South Shields Highway District, and Lanchester Highway District, in the county

of Durham, Provisional Order.

Whereas, in pursuance of the provisions of the Act 25 and 26 Vic., cap. 61, for the better management of Highways in England, notice was given by Anthony Wilkinson, Thomas Joseph Bradshaw, Francis Greenwell, and Edgar John Meynell, Esquires, and the Reverend Arthur Duncombo Shafto for of Her Majora's Institute. Duncembe Shafto, five of Her Majesty's Justices of the Peace for this county, by writing under their hands requiring the Clerk of the Peace to add to or send with the notice required by law to be given of the holding of the then next General Quarter Sessions, a notice in the form set forth in the said Act, that at this Court a proposal would be made to the Justices for a Provisional Order to carry into effect the objects and purposes hereinafter mentioned or set forth. whereas the said Clerk of the Peace added the said notice to that required by law to be given of the holding of these Sessions, and posted in a pre-paid letter the notice referred to by the said Act, to all the Churchwardens or Overseers of the several parishes or places hereinafter mentioned or referred to. Now at these Sessions, the Justices aforesaid, having entertained the said proposal, and after due consideration had in the premises. It is hereby ordered that that detached portion of the district of the Southwick Urban Sanitary Board in the township of Southwick, and those two several detached parts of the townships of Monk Wearmouth and Fulwell respectively, all in the parish of Monk Wearmouth, all called Simonside, and all situated near Jarrow Slake, in the county of Durham, be and the same are hereby added to the Gateshead and South Shields Highway District; and it is also ordered that there shall be one Waywarden elected for each of the said detached parts of the said three several townships of Southwick, Monk Wearmouth, and Fulwell respectively; and it is further ordered that all parts of the townships of Medomsley, Iveston, and Ebchester, not included within the district of any Urban Sanitary Board, for all purposes be and the same are hereby added to the Lanchester Highway District; and it is further ordered that there shall be one Waywarden elected for each of the said townships of Medomsley, Iveston, and Ebchester; and it is likewise hereby ordered and appointed that at the next General Quarter Sessions, to be holden at the Assize Courts, in the city of Durham, on Monday, the 5th day of April now next ensuing, the confirmation of this Provisional Order by a Final Order shall be taken into consideration.
