

assigned to him, should, until the said Board otherwise prescribed, comprise the area for the time being included in the several Unions named in the Schedule to that Order, and that such District should be termed "The South Wales Audit District ;"

And whereas it is prescribed by Article 2 of the said Order that it shall be the duty of the said District Auditor to audit the Accounts of the Guardians and the Overseers specified in Nos. (1) and (2) of that Article, as well as the Accounts of the other Authorities (and of their Officers) referred to in Nos. (3) and (4) in the following terms :

"(3.) The several other Authorities for the time being whose Accounts are or may be by law subject to be audited by a District Auditor, and whose Districts or the areas of whose jurisdiction are for the time being wholly situated within the said Audit District."

"(4.) Such of the said other Authorities whose Accounts are or may be by law subject to be so audited, and whose Districts or the areas of whose jurisdiction are for the time being partly situated within the said Audit District, as We may by Order under Seal hereafter prescribe."

And whereas the School Board for the said United School District of Cregina is an Authority whose Accounts are subject to be audited by a District Auditor, and such School District is partly situated within the said Audit District :

Now therefore, We, the Local Government Board, in pursuance of the powers given to us by the Statutes in that behalf, hereby Order and Prescribe that it shall be the duty of the said Edward Jones to Audit the Accounts of the said School Board, and of their Officers, in conformity with the provisions contained in Article 3 of the above cited Order ; and for the purpose of such Audit the District of the said School Board shall be deemed to be within the said South Wales Audit District.

(No. 1.)—NOVA SCOTIA—SOUTH-EAST COAST.

ST. MARY RIVER ENTRANCE.

(1.) *Revolving Red Light on Wedge Island.*

THE Government of the Dominion of Canada has given notice, that on 1st December, 1879, a light would be exhibited from a lighthouse recently erected on Wedge Island, approach to St. Mary River and Jegogan Harbour :—

The light is a revolving red light, showing for an interval of one minute in every three minutes, elevated 71 feet above high water, and should be visible in clear weather from a distance of 12 miles.

The illuminating apparatus is catoptric, or by reflectors.

The lighthouse, 44 feet high, consists of a square tower, constructed of wood and painted white, with keeper's dwelling attached.

Position as given, lat. 45° 0' 35" N., long. 61° 52' 35" W.

UNITED STATES.

LONG ISLAND SOUND—NEW YORK.

(2.) *Stratford Middle Ground Light—Alteration in Character.*

The United States Government has given notice, that on 15th December, 1879, the following alteration would be made in the character of the flashing light exhibited on Stratford Middle Ground, Long Island Sound :—

The intervals between the flashes of the light are changed from fifteen seconds to ten seconds.

ERRATUM :—In Notice to Mariners, No. 136, of 13th September, 1879, at first line of paragraph 4, read after reported danger—(lat. 46° 29' N., long. 49° 41' W.)—wrongly placed after 9 fathoms, in the first line of paragraph 3, as the position of Eastern Rocks.

NOTICE TO MARINERS.

(No. 2.)—UNITED STATES—COAST OF MAINE—
PENOBSCOT BAY.

(1.) *Fog Signal at Owl's Head.*

THE United States Government has given notice, that a fog signal has been established on the edge of the bluff 100 feet north-east of Owl's Head Lighthouse, approach to Rockland Harbour, west side of Penobscot Bay.

The signal is a bell, which during thick or foggy weather, will be struck four times every minute.

CHESAPEAKE BAY—TANGIER SOUND.

(2.) *Fixed Light and Fog Signal at Jane Island.*

Also, with reference to Notice to Mariners, No. 26 (2), of 20th February, 1879, on the destruction by ice of Jane Island Lighthouse, east side of Tangier Sound :—

Further notice is given, that on 20th December, 1879, a light would be exhibited from a screw pile lighthouse recently erected on the southern extremity of the shoal extending from Jane Island, about 300 feet westward of the old lighthouse.

The light is a fixed white light of the fourth order, elevated 38 feet above high water, and should be visible in clear weather from a distance of 11 miles. It serves as a guide into Little Annamessix River.

The superstructure of the lighthouse is painted white ; roof and foundation brown.

Position approximate, lat. 37° 57' 50" N., long. 75° 55" W.

Also, that during thick or foggy weather a bell will be struck by machinery every fifteen seconds.

COAST OF GEORGIA.—SAVANNAH RIVER.

(3.) *Withdrawal of Tybee Knoll Light-Vessel.*

Also, that on 1st January, 1880, Tybee Knoll Light-vessel would be withdrawn from her station near Savannah River Entrance.
