THE Queen has been graciously pleased to signify Her intention to confer the decoration of the Victoria Cross upon the undermentioned Non-Commissioned Officer and Men of Her Majesty's Army, whose claims have been submitted for Her Majesty's approval, for the gallant conduct displayed by them during the recent operations in South Africa, as recorded against their names:—

Regiment.	Name.	Act of Courage for which recommended.
80th Foot	Colour-Sergeant Anthony Booth	For his gallant conduct on the 12th March, 1879, during the Zulu attack on the Intombi River, in laving, when considerably outnumbered by the enemy, rallied a few men on the south bank of the river, and covered the retreat of fifty soldiers and others for a distance of three miles. The Officer Commanding 80th Regiment reports that, had it not been for the coolness displayed by this Non-commissioned Officer, not one man would have escaped.
94th Foot	Privates Flawn and Fitz-patrick.	In recognition of their gallant conduct during the attack on Sekukuni's Town on the 23th November last, in carrying out of action Lieutenant Dewar, 1st Dragoon Guards, when badly wounded. At the time when he received his wound, Lieutenant Dewar had with him only Privates Flawn and Fitzpatrick, and six of the Native Contingent, and, being incapable of moving without assistance, the natives proceeded to carry him down the hill, when about thirty of the enemy appeared in pursuit about 40 yards in the rear, whereupon the men of the Native Contingent deserted Lieutenant Dewar, who must have been killed but for the devoted gallantry of Privates Flawn and Fitzpatrick, who carried him alternately, one covering the retreat and firing on the enemy.
