THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of an Ordinance of Maritime Health issued by the Italian Government, which decrees that in consequence of yellow fever at Rio Janeiro and Santos, all arrivals from the coast of Brazil will be considered as having a foul bill of health for yellow fever and will be subjected to the treatment agreed upon by Ordinance No. 9 of the 29th May, 1878.
