the same new parish and benefice.

"" That of the said sums of forty-four pounds nineteen shillings and two pence first fruits and of four pounds nine shillings and eleven pence tenths respectively charged upon the Lower Mediety of the rectory of Malpas aforesaid the sums of nine pounds nineteen shillings and eight pence first fruits and of one pound tenths shall from and after the next avoidance of the said Lower Mediety of Malpas be charged npon the new parish and benefice of Saint Chad Malpas otherwise Saint Chad Tushingham and shall be paid by the vicar or incumbent thereof.

"That upon the said division of the said present benefice of Malpas into two benefices and rectories taking effect and in consideration of the endowments and augmentation of the said new parish and benefice of Saint Chad Malpas otherwise Saint Chad Tushingham from the titles of Malpas as aforesaid the patronage of the said new parish and benefice of Saint Chad Malpas otherwise Saint Chad Tushingham and of the church thereof shall for ever be transferred to and vest in and belong to the said Thomas Tyrwhitt Drake his successors in title and assigns to be held and enjoyed in the same right and for the same estate and estates as the advowson or right of presentation to the Lower Mediety of Malpas aforesaid now is or would have been held if this plan had not been made.
