WHEREAS by an Act passed in the first session of the Parliament holden in the first and second years of the reign of Her present Majesty, intituled "An Act to abridge the holding "of benefices in plurality, and to make better "provision for the residence of the clergy, " after reciting that "Whereas in some instances tithings, "hamlets, chapelries, and other places or districts "may be separated from the parishes or mother " churches to which they belong with great "advantage, and places altogether extra-parochial "may in some instances with advantage he annexed "to parishes or districts to which they are con-"tiguous, or be constituted separate parishes for "ecclesiastical purposes," it is, amongst other things, enacted, "That when, with respect to his "own diocese, it shall appear to the Archbishop "of the Province, or when the Bishop of any "diocese shall represent to the said Archbishop "that any such tithing, hamlet, chapelry, place, or "district within the diocese of such Archbishop, "or the diocese of such Bishop, as the case may "be, may be advantageously separated from any " parish or mother church, and either be consti-"tuted a separate benefice by itself or be united "to any other parish to which it may be more
