THE FAIRS ACT, 1873.

CHEPSTOW FAIRS.

WHEREAS a representation has been duly made to me, as Secretary of State for the Home Department, by Justices acting in and for the Petty Sessional Division of Chepstow, in the county of Monmouth, that Fairs have been annually held in the town of Chepstow, in the said division of the said county, on the last Monday in each calendar month, and that it would be for the convenience and advantage of the public that the day for the holding of such Fair should be altered, and that instead of being held as aforesaid, such Fairs should in future be held on the last Tuesday in each calendar month:

And whereas notice of the said representation, and of the time when I should take the same into consideration, has been duly given to the owner of the said Fair, and otherwise published in pursuance of "The Fairs Act, 1873:"

And whereas on such representation and consideration it appears to me that it would be for the convenience and advantage of the public that the time for the holding of the said Fair should be altered as proposed:

Now, therefore, I, as the Secretary of State for the Home Department, in exercise of the powers vested in me by "The Fairs Act, 1873," do hereby order that the day shall be altered for the holding of the Fair, which has been annually held in the town of Chepstow, on the last Monday in each calendar month, and that instead of being held as aforesaid, such Fair shall in future be held on the last Tuesday in each calendar month.
