PART I.

Area Infected with Pleuro-Pneumonia.

An area comprising the whole of the park known as Studley Royal Park, the property of the Marquis of Ripon, and situate in the township of Lindrick-with-Studley-Royal-and-Fountains, in the Kirkby Malzeard Petty Sessional Division of the West Riding of the county of York.

PART II.

Place Infected with Pleuro-Pneumonia situate within the foregoing Area.
