(1.) Temporary Re-Exhibition of South Harbour. Light and Opening of South Harbour.

WITH reference to Notice to Mariners, No. 180, of 20th November, 1879, on the discontinuance of South Harbour Light, and closing of South Harbour, Peterhead :-

The Peterhead Harbour Authorities have given further notice, that on 12th July, 1880, the light at the entrance of Peterhead South Harbour will be re-exhibited during the herring fishing season, until 15th September, 1880, when it will be discontinued.
