"We the said Ecclesiastical Commissioners humbly recommend and propose that without any conveyance or assurance in the law other than this scheme and any duly gazetted Order of your Majesty in Council ratifying the same and as and from the day of the date at which the said benefice and rectory of Saint Botolph Bishopsgate in the said city of London shall from whatsoever cause be next avoided all the endowments whatsoever or wheresoever now belonging or which may hereafter belong to the said benefice and rectory of Saint Botolph Bishopsgate shall be chargeable and be for ever thereafter charged in favour of the rector or incumbent for the time being of the said benefice and rectory of Saint Giles-in-the-Fields in the said county of Middlesex with one clear annual sum or yearly charge of three hundred pounds the same annual sum or yearly charge of three hundred pounds to be as from the day aforesaid due and payable to the rector or incumbent of the said benefice and rectory of Saint Giles-in-the-Fields and to be apportionable between any outgoing rector or incumbent of the benefice and rectory of Saint Giles-in-the-Fields or his representatives and his successor in the same benefice and rectory, and to be receivable by each such rector or incumbent by equal half yearly payments on the first day of May and the first day of November in every year the first of such half yearly payments to be made on that one of the said two days (namely the first day of May and the first day of November) which shall come next after the completion of six calendar months from the next avoidance as aforesaid of the said benefice and rectory of Saint Botolph Bishopsgate in the said city of London but so nevertheless that if such avoidance shall happen on any day of the year other than the first of May or the first of November, the rector or incumbent of the said benefice and rectory of Saint Giles-in-the-Fields in the said county of Middlesex shall on the first day of May or (as the case may be) on the first day of November which shall come next after such avoidance be entitled to receive in respect of the said annual sum or yearly charge of three hundred pounds a sum proportioned to the period which shall have elapsed between such avoidance and that one of the said two days which shall come next after the same avoidance.

"And we the said Ecclesiastical Commissioners further recommend and propose with the like consents testified as aforesaid that without any conveyance or assurance in the law other than as aforesaid and as from the day of the date at which the said benefice and rectory of Saint Catherine Coleman, Fenchurchstreet, in the said city of London shall from whatsoever cause be next avoided all the endowments whatsoever or wheresoever now belonging or which may belong to the said benefice and rectory of Saint Catherine Coleman Fenchurch-street shall be chargeable and be for ever thereafter charged in favour of the rector or incumbent for the time being of the said benefice and rectory of Saint Giles-in-the-Fields in the said county of Middlesex with one clear annual sum or yearly charge of one hundred pounds the same annual sum or yearly charge of one hundred pounds to be as from the day last aforesaid due and payable to the rector or incumbent of the said benefice and rectory of Saint Giles-in-the-Fields and to be apportionable between any outgoing rector or incumbent of the benefice and rectory of Saint Giles-in-the-Fields or his representatives and his successor in the same benefice and rectory and to be receivable by each such rector or incumbent by equal half-yearly payments on the first day of May and

last-mentioned half-yearly payments to commence and be payable in manner and upon the dates hereinbefore recommended and proposed with respect to the said proposed charge of three hundred pounds per annam upon the said benefice and rectory of Saint Botolph Bishopsgate in the said city of London.

city of London. "And we further recommend and propose that the rector or incumbent for the time being of the said benefice and rectory of Saint Giles-in-the-Fields in the said county of Middlesex shall have the following powers for recovering each of the said two annual sums or yearly charges, of three hundred pounds and one hundred pounds respectively so as aforesaid proposed to be charged upon the said benefice and rectory of Saint Botolph Bishopsgate in the said city of London, and upon the said benefice and rectory of Saint Catherine Coleman Fenchurch-street in the same city respectively that is to say, power if and whenever any part of the said annual sum or yearly charge of three hundred pounds or (as the case may be) of the said annual sum or yearly charge of one hundred pounds shall at any time be unpaid for twenty-one days after any of the times hereinbefore appointed for the payment thereof (although there shall not have been any legal demand made thereof) to enter into the receipt of the endowments charged therewith or any part thereof and to receive and take the same until he shall thereby or otherwise be paid and satisfied the same rent-charge and the arrears thereof due at the time of such entry or . afterwards to become due during his being in possession of the same premises together with all costs and expenses occasioned by non-payment thereof and for the purpose of collecting receiving and recovering such endowments or any of them to use exercise and enjoy all such powers and remedies for collecting recovering and enforcing payment thereof, as may at the time be vested in the rector or incumbent of the said benefice and rectory of St. Botolph Bishopsgate in the said city of London or (as the case may be) in the rector or incumbent of the said benefice and rectory of Saint Catherine Coleman Fenchurchstreet in the same city.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of either of them or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of London.
