The SCHEDULE to which the foregoing Instrument has reference.

The Particular District of Saint Matthew, Tipton, being:—

All that part of the new parish of Saint Paul, Tipton, in the county of Stafford, and in the diocese of Lichfield, which is bounded on the north by the new parish of Saint John, Tipton, in the said county and diocese, on the west partly by the district parish of Coseley, partly by the parish of Sedgley, and partly by the new parish of Saint Peter, Upper Gornal, all in the county and diocese aforesaid, on the south partly by the new parish of Saint Edmund, Dudley, in the county of Worcester, and in the diocese of Worcester, and upon all other sides, that is to say, on the remaining part of the south and on the east by an imaginary line commencing upon the county boundary which divides the said new parish of Saint Edmund, Dudley, from the new parish of Saint Paul, Tipton aforesaid at a point in the middle of the Castle Tunnel Branch Canal, such point being a little to the west of the Castle Tunnel Bridge which carries Dudley-road over the said canal, and extending thence north-eastward for a distance of eleven chains, or thereabouts, along the middle of the same canal to its junction with the top level of the Birmingham Canal, and extending thence eastward for a distance of six chains, or thereabouts, along the middle of the last-named canal to the centre of Fishers Bridge, which carries the footpath leading from the Dudley-road aforesaid into Park-lane West, over the said last-named canal, and extending thence north-eastward for a distance of nine chains, or thereabouts, along the middle of the said footpath to its junction at the Bush Inn with Park-lane West, and extending thence north-westward for a distance of seventeen chains, or thereabouts, along the middle of the said lane to the centre of Sawney Bridge over the top level of the Birmingham Canal aforesaid, and extending thence for a distance of thirty-five chains, or thereabouts, first northward, then westward, and then again northward along the middle of the last-named canal to its junction with the lower level of the Birmingham Canal, and extending thence eastward for a distance of twenty chains, or thereabouts, along the middle of the last-named canal to the centre of the Wood-street footbridge which carries the footpath leading from Wood-street to Bloomfield and Prince's End over the same canal, and extending thence northward, for a distance of three and a half chains, or thereabouts, along the middle of the last-described footpath to a point in the middle of the line of the Stour Valley Railway, such point being at or near to the junction of the same line of railway with the eastern loop of the Prince's End Branch Line of Railway, and extending thence for a distance of twenty-two chains, or thereabouts, first north-westward, and then northward, along the middle of the said branch line of railway to the boundary

at the centre of the bridge which carries the same branch line of railway over the top level of the Birmingham Canal aforesaid, which boundary divides the said new parish of Saint Paul, Tipton, from the new parish of Saint John, Tipton aforesaid.

THE Lords of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, (in this Order referred to as the Act of 1878,) and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The limits of the area which is described in the Order of Council dated the eleventh day of January, one thousand eight hundred and eighty-one, and is thereby declared to be an area infected with foot-and-mouth disease, namely—the Petty Sessional Divisions of Alton, Basingstoke, Fareham, Havant, Odiham, Petersfield, and Southampton, in the county of Southampton, and the boroughs of Basingstoke, Portsmouth, and Southampton, except as follows:—The Royal Clarence Victualling Yard and the other lands and buildings in the port of Portsmouth approved by the Privy Council for the landing or lairage of foreign animals; the foreign animals wharf, and the foreign animals quarantine stations, and the other lands and buildings in the port of Southampton, approved or defined by the Privy Council for the landing or lairage or for the quarantine of foreign animals; and such landing-places in the port of Southampton as were at the date of that Order used for the landing of animals from Ireland;—are hereby extended so as to include the area described in the Schedule to this Order, except the lines of railway within that last-mentioned area, as far as those lines are used or required for the transit of animals through that last-mentioned area, without being untrucked within it (with which transit nothing in this Order shall be deemed to interfere); and the area described in the Schedule to this Order, except as aforesaid, is hereby declared to be an area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the seventeenth day of February, one thousand eight hundred and eighty-one; and words in this Order have the same meaning as in the Act of 1878.
