To the Churchwardens and Overseers of the Poor of the town of Folkestone, in the county of Kent ;-

And to all others whom it may concern.

W HEREAS the population of the said town of Folkestone, according to the last Census, exceeds two thousand persons;

And whereas at a Meeting of the Vestry of the said town, held, pursuant to public notice in that behalf, on Friday, the 20th day of August, 1830, it was resolved,-

"That the Local Government Board be re-" quested to issue an Order under their Seal " of Office, directing that the Act passed in " the 14th year of the reign of Her present "Majesty (13 and 14 Vict., cap. 57), inti-"tuled 'An Act to prevent the holding of " 'Vestry or other Meetings in Churches "' and for regulating the Appointment of "' Vestry Clerks,' shall be applied to and " put in force in the township of Folkestone, " with regard to that portion of it only which "relates to the appointment of a Vestry " Clerk, and that the amount of salary to be "assigned to the Vestry Clerk be £40 per "annum for the performance of the duties " specified in clauses 1, 2, 3, 4, and 14 of "Section 7 of the said Act."

And whereas the Churchwardens of the said town have made application in writing to the Local Government Board, pursuant to the above **Resolutions**:

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us

follows :

ARTICLE I .- So much of the Act passed in the fourteenth year of the reign of Her Majesty, intituled "An Act to prevent the holding of Vestry " or other Meetings in Churches, and for regulat-"ing the Appointment of Vestry Clerks," as relates to the appointment of a Vestry Clerk, shall forthwith be applied to and be put in force

within the said town of Folkestone ; ARTICLE II.—The duties of the Vestry Clerk for the time being appointed under the authority of the Statutes in that behalf and of this Order shall be as follows :

To give notice of and attend the Meetings of Vestry and Committees appointed thereat.

- To summon and attend Meetings of the Churchwardens and Overseers, when required, and to enter the minutes thereof respectively.
- To keep the accounts of all Charity Moneys which the Churchwardens or Overseers are authorized or are accustomed to distribute.
- To keep the Vestry Books and the Parish deeds and documents, and the Rate Books and Accounts which are closed, and to give copies of and extracts from the same to any person entitled thereto, such person paying for the same at the rate of Four pence for every seventy-two words or figures, and to permit any person or persons rated to the relief of the Poor of the said Parish, at all reasonable times, to inspect the same or any of them, on pain of dismissal for neglecting to give such copies or permit such inspection.
- To advise the Churchwardens and Overseers in all the duties of their office.

ARTICLE III.- The Churchwardens and Overseers of the Poor of the said town shall pay to the person for the time being appointed to the office of Vestry Clerk, under the provisions of the above-mentioned Act and of this Order a salary at the rate of Forty Pounds per annum, or such other remuneration for the performance of the duties of that office as the Local Government Board may, with the consent of such person, from time to time direct or approve.

ARTICLE IV .- Such remuneration, in the case of an annual salary, shall be considered as accruing from day to day, and be apportionable in respect of time accordingly, in pursuance of the provisions of "The Apportionment Act, 1870," and shall be paid quarterly on the usual Quarter Days in each year, namely, Lady Day, Midsummer Day, Michaelmas Day, and Christmas Day.

ARTICLE V.--A copy of this Order shall be published in the London Gazette by the Churchwardens and Overscers of the Poor of the said town.
