such benefices, sinecure rectories, or vicarages, "with notice to any person or persons interested, that he, she, or they, may, within such six weeks, show cause in writing under his, her, or "their hand or hands, to the said Archbishop, " against such union; and if no sufficient cause • be shown within such time, the said Archbishop * shall certify the inquiry and consent aforesaid "to Her Majesty in Council, and thereupon it * shall be lawful for Her Majesty in Council to " make and issue an Order or Orders for uniting 46 such benefices, sinecure rectory or rectories, "vicarage or vicarages, into one benefice, with " cure of souls, for ecclesiastical purposes only."

And whereas the Lord Archbishop of Canterbury, pursuant to the provisions of the said Act, hath duly prepared and laid before Her Majesty in Council a certificate in writing, bearing date the twenty-fifth day of April, in the year of our Lord one thousand eight hundred and eighty-one, in the words following, that is to say :-

"To the QUEEN's Most Excellent Majesty in Council.

"We the undersigned Archibald Campbell Lord Archbishop of the Province of Canterbury Primate of all England and Metropolitan do hereby certify

to your Majesty in Council:—
"That the Honourable and Right Reverend John Thomas Lord Bishop of Norwich having represented unto us that the vicarage or perpetual curacy of Mundham and the vicarage or perpetual curacy of Seething both in the county of Norfolk and diocese of Norwich being contiguous to each other and of which the aggregate population does not exceed six hundred and seventy-one persons might with advantage to the interests of religion be united into one benefice we inquired into the circumstances of the case.

"That on such inquiry it appeared to us that such union might be usefully made and would not be of inconvenient extent and that the Trustees of the Great Hospital in the city of Norwich being the patrons or persons entitled to present to each of the said benefice if the same respectively were now vacant have signified their consent in writing to the union of the said benefices into one benefice with cure of souls for ecclesiastical purposes.

"That six weeks and upwards before certifying such inquiry and consent to your Majesty in Council we caused a copy in writing of the aforesaid representation of the said Lord Bishop to be affixed on the principal outer door of the parish church of each of the said benefices with notice to any person or persons interested that he she or they might within such six weeks show cause in writing under his her or their hand or hands to us the said Archbishop against such union and no such cause has been shown.

"The representation of the said Lord Bishop of Norwich our inquiry into the circumstances of the case the statement of circumstances in reply thereto the consent in writing of the patrons and the copies of the representation and notice before

mentioned are hereunto annexed.

"And we do hereby certify the inquiry and consent aforesaid to your Majesty in Council to the intent that your Majesty in Council may in case your Majesty in Council shall think fit so to do make and issue an Order for uniting the said benefices into one benefice with cure of souls for ecclesiastical purposes only.

"As witness our hands this twenty-fifth day of April one thousand eight hundred and eighty-one. "A. C. Cantuar."

Now therefore Her Majesty in Council by and with the advice of Her said Council is pleased to order and it is hereby ordered that the vicarage or perpetual curacy of Mundham situate in the county of Norfolk and diocese of Norwich and the vicarage or perpetual curacy of Seething situate in the same county and diocese shall be united into one benefice with cure of souls for ecclesias-C. The QUEEN's Most Excellent Majesty in Council. WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the thirty-second and thirty-third years of Her Majesty chapter ninety-four duly prepared and laid before Her Majesty in Council a scheme or representation bearing date the twenty-eighth day of April, in the year one thousand eight hundred and eighty-one, in the words following,

that is to say :-

"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the thirty-second and thirty-third years of your Majesty, chapter ninety-four, have prepared and now humbly lay before your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of Saint Alban, Cheetwood, within the limits of the original parish of Manchester, in the county of Lancaster, and in the diocese of Manchester.

"Whereas by the authority of an Order of your Majesty in Council bearing date the twentieth day of October in the year one thousand eight hundred and seventy-four and published in the London Gazette upon the same day a certain part of the said original parish of Manchester then remaining attached to and constituting the cure annexed to the cathedral and parish church of Manchester (which said cure is hereinafter called the residuary parish of Manchester) was constituted a district for spiritual purposes and was annexed to the consecrated church of Saint Alban situate at Cheetwood within the limits of such district and the same was called 'The District of Saint Alban, Cheetwood.'

"And whereas the said district of Saint Alban, Cheetwood, has under the provisions of the Act of the nineteenth and twentieth years of your Majesty chapter one hundred and four become a new parish of the character contemplated by that Act and by the Act of the sixth and seventh years of your Majesty chapter thirty-seven and of the said above-mentioned Act of the thirty-second and thirty-third years of your Majesty chapter

ninety-four.

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said new parish of Saint Alban, Cheetwood, should be altered in the manner hereinafter mentioned.

"Now, therefore, with the consent of the Right Reverend James Bishop of the said diocese of Manchester (in testimony whereof he has signed and sealed this scheme or representation) we the said Ecclesiastical Commissioners humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of an Order of your Majesty in Council ratifying this scheme or representation the boundaries of the said new parish of Saint Alban, Cheetwood, shall be altered so as to dissever from such new parish all that part thereof which is described in the schedule hereunder written and which is delineated and set forth upon the map or
