THE Board of Trade have received through the Secretary of State for Foreign Affairs copies of Proclamations respecting quarantine at Mobile and Pensacola, which are as follows :-

> Office of President of Mobile Police Board, Mobile, April 30, 1881.

By authority vested in me by the Police Board of the Port of Mobile, and upon the recommendation of the Board of Health, I, Richard B. Owen, President of the said Police Board, do hereby issue this my Proclamation, and do declare that from and after the 1st day of May, 1881, a rigid quarantine shall be enforced against all vessels, their officers, crews, and passengers, which shall come to the Bay of Mobile from the ports of Mexico, South America, and the West Indies, and from other ports wherein infectious and contagious diseases are known to prevail, or may hereafter. prevail; said quarantine to continue in force until the 1st day of December next, unless-sooner revoked.

Mayor's Office, April 18, 1881.

AT a meeting of the Board of Health, held April 16th, 1881, it was

Resolved, That the Mayor shall issue his proclamation directing the establishment of quarantine, the same to commence on 1st day of May, 1881, and remain in force until removed by the Board of Health.

In obedience to the above resolution, notice is hereby given, that on and after the 1st proximo, quarantine will go into effect. 'Pilots'and masters of tugs bringing vessels into port will hoist a flag at half-mast at the fore, and take them to the buoy off Deer Point, where they will remain until disposed of by the Quarantine Physician. No person after that date will be permitted to go on board of said vessel until boarded by Quarantine Physician and released from quarantine. Naval Guard stationed at Deer Point, by courtesy of the naval authorities, are clothed with the execution of the rules of Board of Health.

The orders of the guard, in executing said rules and instructions, must be respected by all vessels and persons in the bay, between Clapp's Woods on west side of Quarantine Station and Town Point, and extending to a line across Santa Rosa Sound, three miles east of Deer Point.
