## .(4.) Reported Sunken Rock Westward of Koh Rong.

Also, of the existence of a sunken rock lying about 27 miles westward of Koh Rong, eastern shore of the Gulf of Siam :--

This rock (Jan Peter) on which the German barque "Jan Peter" grounded at 8 A.M., on 21st December, 1880, is stated to have two fathoms water over it, and as seen from aloft was estimated to be about two ships' lengths in extent; the following bearings were observed from the vessel when aground, viz. :-

Koh Kong summit, N.N.E.

Koh Rong summit, E. 2 S. Rong Sam Lem summit, E. by S.

About two hours after grounding the tide had risen about 10 feet, and the vessel backed off the danger, striking heavily from the easterly swell.

The above bearings would place Jan Peter Rock about 22 miles W.S.W. of Koh Samit (nearest land), or in lat. 10° 45' N., long. 102° 42' E., but from the nature of the account received, the position must be regarded as approximate. Mariners therefore should navigate in the vicinity with great caution.

Variation 2° The bearings are magnetic. Easterly in 1881].

(1.) Tuslinski Light-vessel replaced in Position.

THE Russian Government has given notice, dated 7th April, 1881, that Juslinski (Kertchenski) Light-vessel has been i laced in position near the south-west extrem t Tuzla Bank, Kertch Strait.

## (2.) Yenikale Channel—Dredging Operations Resumed.

With reference to Notice to Mariners, No. 189, 14th October, 1880, on the depth of water in the deep channel of Yenikale, Kertch Strait :-
