WITH reference to Notice to Mariners,
No. 139 (3), of 7th August, 1880, and No. 181,

of 25th September, 1880, on the intended extension of the breakwater in Odessa Bay:

The following further information relative to the extension of breakwaters and exhibition of lights has been received from Lieutenant and Commander Honourable W. H. Joliffe, Her Majesty's Ship "Antelope":-

The seaward breakwater, projecting from Vorontzovski Mole, has been completed by its extension in a W.N.W. direction for a distance of about 350 yards. A new breakwater, the southeast end of which bears S.W. by S., distant about 1½ cables from the extremity of the seaward breakwater, is in course of construction, and already extends in a north-westerly direction for about 3 cables, the south-eastern portion being completed.

At the entrance between the seaward and new breakwaters, the depths are from 6 to 8 fathoms. A buoy is moored near the south-east extremity

of the new breakwater. There are exhibited from the extremity of Vorontzovski Mole three red lights, placed
