Alexandria, July 21.—In consequence of cessation of plague in Mesopotamia, Egyptian Sanitary Conncil decided to-day to admit arrivals from Syria to free pratique. Vessels from Red Sea ports to undergo medical inspection. Rags and other highly susceptible goods repulsed. Arrivals from Persian Gulf are to undergo fortyeight hours' quarantine of observation at Moses' Wells, Suez. Susceptible goods disinfected at Aden are admitted to Egypt, except rags. Vessels carrying rags are not allowed pratique, but may transmit through Suez Canal in quarantine.
