By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. This Order shall take effect from and immediately after the twelfth day of August, one thousand eight hundred and eighty-one.

2. The limits of the following area which is declared by Order of Council dated the third day of August, one thousand eight hundred and eighty-one, to be an area infected with foot-and-mouth disease (namely),—so much of the parish of Wootton Rivers, in the county of Wilts, as is bounded on or towards the north by the lane from Clench to the street in Wootton Rivers village inclusive of such last-mentioned lane, on or towards the east by the highway through Wootton Rivers village inclusive of such highway, on or towards the south by the Berks and Hants Extension Railway, and on or towards the west by the boundary of the Manor Farm in the occupation of Mr. William Crook in the said parish,—are hereby extended so as to include the area described in the Schedule to this Order, and the area described in the Schedule to this Order is hereby declared to be an area infected with foot-and-mouth disease.

An area comprising the parish of Wootton Rivers, in the county of Wilts, and so much of the parish of South Savernake Brimslade and Cadley, in the said county, as lies to the south of the Marlborough Railway.

SCHEDULE.

An area comprising that portion of the parish of Millbrook, in the petty sessional division of Southampton, in the county of Southampton, which is bounded on the south by the Southampton Water, on the east by the Shirley-road and the Romsey-road as far as the Old Toll Bar, on the north by Brownhill-lane and Redbridge-lane to the River Test, and on the west by the River Test.

THE CONTAGIOUS DISEASES (ANIMALS) ACT, 1878.

THE following areas are now *Areas Infected with Foot-and-Mouth Disease* under the above-mentioned Act (except the lines of railway within those areas as far as those lines are used or required for the transit of animals through those areas, without untrucking):—

Cambridgeshire (Isle of Ely).—The whole of the parish of Thorney, and that part of the parish of Wisbech, which is situate to the west of the Old South Eau Bank, in the Liberty of the Isle of Ely.

Derbyshire.—(1.) The whole of the petty sessional division of Derby, in the county of Derby, and the borough of Derby.

(2.) The petty sessional divisions of Ashbourne, and Sudbury, in the county of Derby.

(3.) The parish of Crich, in the petty sessional division of Belper, in the county of Derby.

(4.) The petty sessional division of Swadlincote, in the county of Derby.

(5.) The petty sessional division of Repton and Gresley, in the county of Derby.

(6.) The park, grounds, and premises known as Egginton Hall, in the parish of Egginton, in the county of Derby.

Dorsetshire.—(1.) The parishes of Turnworth, Winterbourne Clenston, Winterbourne Houghton, and Winterbourne Stickland, in the petty sessional division of Blandford, in the county of Dorset.

(2.) The parishes of Tarrant Keinston, and Tarrant Rawston, in the petty sessional division of Blandford, and the parishes of Preston-cum-Crawford, Tarrant Rushton, and Witchampton, in the petty sessional division of Wimborne, in the county of Dorset.

(3.) The parishes of Chaldon Herring, West Lulworth, and Winfrith Newburgh, in the petty sessional division of Wareham, and Owermoigne, in the petty sessional division of Dorchester, in the county of Dorset.
