THE Lords Commissioners of Her Majesty's Treasury hereby give notice, that in pursuance of the powers vested in them by section 8 of the Act 42 and 43 Vic., cap. 44, the notices in the London Gazette of 16th December, 1870, and 7th February, 1871, whereby all situations in the departments of Her Majesty's General Register House, Edinburgh, therein specified, were added to the Schedule marked B, annexed to Her Majesty's Order in Council of the 4th of June, 1870, are hereby repealed, and in lieu thereof the said Lords Commissioners hereby give notice, that all situations in Her Majesty's Register House, Edinburgh, as regulated by the minute of the said Lords Commissioners, dated 27th March, 1881, are added to Schedule A. of the Order in Council of 4th June, 1870.

#### PORT OF SHOREHAM.

LIMITS OF PORT AND LEGAL QUAY.

WE, the undersigned, Lords Commissioners of Her Majesty's Treasury of the United Kingdom of Great Britain and Ireland, do hereby, under the authority of "The Customs Consolidation Act, 1876," appoint Shoreham to be a port in that part of the United Kingdom called England, and do hereby declare that the limits of the said port shall commence at the north-eastern part of the parish of Rottingdean, in the county of Sussex, being the western boundary of the port of Newhaven, and shall extend along the coast of the said county of Sussex, in a westerly direction, to the most eastern part of the parish of Heene, in the county aforesaid, being the eastern boundary of the Port of Littlehampton, and shall include all harbours, rivers, bays, and creeks within the aforesaid limits, and shall extend seaward, from low-water mark, along the coast, within the aforesaid limits, to a distance of three miles.
