mentioned boundary for a distance of forty-six chains or thereabouts thereby following the shore of the River Severn aforesaid to a point a little to the north of New Passage at the mouth of the Chestle Pill and extending thence that is from the said last-mentioned boundary south-eastward up the main channel of the said Chestle Pill as far as the boundary which divides the said parish of Henbury from the parish of Almondsbury aforesaid and extending thence in a direction for the most part north-eastward along the last-described boundary for a distance of a little more than a mile to its junction with the boundary dividing the lastnamed parish from the parish of Olveston as a'oresaid and extending thence in a direction for the most part south-eastward along the last-described boundary for a distance of two miles and fifteen chains or thereabouts to the point in the middle of the stream called or known as the Mill Rheen as aforesaid where the said imaginary line commenced."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts ; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the respective Registrars of the said diocese of Gloucester and Bristol in the diocesan registries at Gloucester and at C. L. Peel. Bristol respectively.

W⁷ HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her Majesty, chapter forty-nine ; of the Act of the eleventh and twelfth years of Her Majesty chapter thirty-seven ; of the Act of the fourteenth and fifteenth years of Her Majesty chapter ninety-seven ; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the twenty-first day of July in the year one thousand eight hundred and eighty-one, in the words and figures following; that is to say :-

"We the Ecclesiastical Commissioners for England in pursuance of the Act of the fiftyninth year of His Majesty King George the Third chapter one hundred and thirty-four, of the Act of the second and third years of your Majesty chapter forty-nine, of the Act of the eleventh and twelfth years of your Majesty chapter thirty-seven, of the Act of the fourteenth and fifteenth years of your Majesty chapter ninety-seven, and of the Act of the nineteenth and twentieth years of your Majesty chapter fifty-five have prepared and now humbly lay before your Majesty in Council the following representation as to the assignment of a district chapelry to the consecrated church of Saint Saviour situate in Coplestone-road in the new parish of Saint John the Evangelist, East Dulwich in the county of Surrey and in the diocese of Rochester.

"Whereas it appears to us to be expedient that. a district chapelry should be assigned to the said church of Saint Saviour situate in Coplestoneroad as aforesaid.

" Now therefore with the consent of the Right Reverend Anthony Wilson Bishop of the said. diocese of Rochester (testified by his having signed and sealed this representation) we the said Ecclesiastical Commissioners humbly represent that it would in our opinion be expedient that all that part of the said new parish of Saint John the Evangelist, East Dulwich, which is described in the schedule hereunder written all which part together with the boundaries thereof is delineated and set forth on the map or plan hereunto annexed should be assigned as a district chapelry to the said church of Saint Saviour situate in Coplestone-road as aforesaid and that the same should be named 'The District Chapelry of Saint Saviour Champion Hill.

"And with the like consent of the said Anthony Wilson Bishop of the said diocese of Rochester (testified as aforesaid) we the said Ecclesiastical Commissioners further represent that it appears to us to be expedient that banns of matrimony should be published and that marriages baptisms churchings and burials should be solemnized or performed at the said church of Saint Saviour situate in Coplestone-road as aforesaid and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being Provided always that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We therefore humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration and to make such Order with respect thereto as to your Majesty in your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Saviour Champion Hill, being :-

"All that part of the new parish of Saint John the Evangelist East Dulwich in the county of Surrey and in the diocese of Rochester which is bounded on the south by an imaginary line commencing upon the boundary which divides the said new parish from the new parish of All Saints. Blenheim-grove in the county and diocese aforesaid at the point where Maxted-road is joined by McDermott-road and extending thence southward along the middle of the said Maxted-road for a distance of one chain or thereabouts to its junction with Oglander-road and extending thence south-westward along the middle of the lastnamed road for a distance of fifteen chains and a half or thereabouts to the fence at the present south-western termination of the same road at a point opposite to a boundary-stone inscribed C. H. St. S. D. C. 1881, No. 1' and placed on the western side of such road a little to the south of the house called or known as Holton House and extending thence in a straight line due west for a distance of eight and a half chains or thereabouts to another boundary-stone inscribed 'C. H. St. S. D. C. 1881, No. 2' and placed on the western side of Coplestone-road at or near to its present southern termination at the eastern extremity of the fence forming the south-eastern and south-western boundaries of the house and
