premises known as Ferndale, Coplestone-road, and extending thence first south-westward and then north-westward along the last-described fence for a distance of three and a half chains or thereahouts to its north-western end on the eastern side of the Peckham and Sutton line of the London Brighton and South Coast Railway and continuing thence still north-westward and in a direct line across the said line of railway to a point at the south-eastern end of the fence which forms the south-western boundary of the houses and premises situate on the south-western side of Bromar-road and extending thence north-westward for a distance of fourteen and a half chains or thereabouts along the last-described fence and along the fence which forms the south-western boundary of the houses and premises situate on the southern side of the upper part of Grove Hill-road to the north-western end of the last-described fence on the southern side of the said Grove Hill-road at or near its junction with the footway called or known as Cut Throat-lane and continuing thence still north-westward and in a direct line to the boundary on the northern side of the said Grove Hill-road at the south-western end of the said Cut Throat-lane which boundary divides the said new parish of Saint John the Evangelist East Dulwich from the parish of Camberwell in the county and diocese aforesaid All which abovedescribed part of the new parish of Saint John the Evangelist East Dulwich aforesaid is bounded on the sides other than the south that is to say upon the north-west and upon the north-east by the said parish of Camberwell and by the said new parish of All Saints Blenheim-grove respectively."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Rochester. The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the sixteenth and seventcenth years of Her Majesty chapter fifty and of the Act of the twenty-third and twenty-fourth years of Her Majesty chapter one hundred and twenty-four duly prepared and laid before Her Majesty in Council a scheme, being date the twenty-eighth day of July, in the year one thousand eight hundred and eighty-one, in the words and figures following, that is to say :-

"We the Ecclesiastical Commissioners for England in pursuance of the Act of the sixteenth and seventeenth years of your Majesty chapter fifty and of the Act of the twenty-third and twentyfourth years of your Majesty chapter one hundred and twenty-four have prepared and now humbly lay before your Majesty in Council the following scheme for effecting an exchange of the patronage of the benefice (being a vicarage or perpetual curacy) of Gentleshawe in the county of Stafford and benefice (being a vicarage) of Abbots Bromley in the same county and diocese.

"Whereas the Right Reverend Father in God William Dalrymple by Divine permission Lord Bishop of Lichfield (in right of his See) and the Dean and Chapter of Lichfield are seized of the advowson or perpetual right of patronage nomination and presentation of and to the vicarge or perpetual curacy of Gentleshawe aforesaid the said right of patronage nomination and presentation being exerciseable by the said Bishop and the said Dean and Chapter alternately the next right of presentation being in the said Dean and Chapter of Lichfield for the time being.

"And whereas the advowson or perpetual right of patronage nomination and presentation to the vicarage of Abbots Bromley aforesaid is now vested in the Right Honourable Henry fourth Marquis of Anglesey as tenant for life with divers remainders over under and by virtue of a certain indenture of settlement dated the first day of December one thousand eight hundred and forty-three and made between William Lowe of the first part Henry William Marquess of Anglesey (since deceased) of the second part the Right Honourable Henry Baron Paget (commonly called Earl of Uxbridge) and the Right Honourable Henrietta Maria Baroness Paget (commonly called Countess of Uxbridge) of the third part, the Right Hon-. ourable Henry William George Paget (commonly called Lord Paget) of the fourth part the said William Lowe and Robert Manley Lowe of the fifth part the Most Noble Charles Duke of Richmond and the Honourable William Bagot of the sixth part the said Charles Duke of Richmond and the Right Honourable John Robert Earl Sydney (then John Robert Viscount Sydney) of the seventh part the said William Bagot and the Right Honourable George Stevens Byng of the eighth part the Right Honourable Edward Lord Crofton and Frederick Paget Esquire of the ninth part and the Right Honourable John William Earl of Sandwich and Henry William Paget Esquire of the tenth part in which indenture is contained a power for certain trustees therein mentioned at the request and by the direction of the person who under the limitations of the said indenture should be entitled for the time being to the possession or the receipt of the rents and profits of the hereditaments and premises thereby settled to sell or exchange for other manors lands or hereditaments in England or Wales all or any of the said hereditaments and premises thereby settled.

- "And whereas the said John Robert Earl Sydney is the sole Trustee of the said indenture by whom the said power of sale is now exerciseable.
- " And whereas the said Robert William Dalrymple Lord Bishop of Lichfield, the said Dean. and Chapter of Lichfield the said Henry fourth Marquess of Anglesey and the said John Robert Earl Sydney have signified to us their desire that the patronage of the said several benefices may be exchanged as hereinafter recommended and proposed.
- "And whereas we have made due inquiry and calculation as to the circumstances and relative values of the said benefices of Gentleshawe and Abbots Bromley and the patronage thereof respectively and we do hereby certify to your Majesty that such circumstances and values respectively are set forth in the two parts of the schedule hereto annexed and it has been made to appear to us that the said exchange would be in conformity with the intention of and expedient for the objects contemplated by the said Acts diocese of Lichfield for the patronage of the hereinbefore mentioned.
