of the last-named lane for a distance of six and a half chains or thereabouts to the boundary which divides the said new parish of Saint Mary Sowerby from the parochial chapelry of Saint Peter Sowerby aforesaid and extending thence first north-westward then westward and then again north-westward along the last-mentioned boundary for a distance of twenty-nine chains or thereabouts thereby passing to the north of the houses called or known respectively as Deer Play and as Spout Field to the point on the northern side of the lastnamed house at or near to the junction of Birkslane, Helm-lane, and Bowood-lane and extending thence north-eastward along the middle of the last-named lane for a distance of fifteen chains or thereabouts to a point opposite to a boundary-stone inscribed T. St. J. C. C. 1881, No. 2,' and placed on the south-eastern side of the said last-named lane at a distance of exactly four chains to the north of the junction of the same lane with Green-lane and extending thence due eastward and in a direct line for a distance of twenty-nine chains or thereabouts thereby passing to the north of the buildings called or known as Field End to the steps at the western end of the passage which leads along the northern side of the cottages in Oak-lane aforesaid at the junction of the last-named lane with the Blackstone Edge trustroad aforesaid and extending thence that is from the said steps south-eastward along the middle of the said passage for a distance of thirty-five feet or thereabouts to Oak-lane aforesaid and continuing thence still in the last-mentioned direction and in a straight line for a further distance of twentynine feet or thereabouts to a point in the middle of the Blackstone Edge trust-road aforesaid opposite to the middle of the northern end of Oak-lane aforesaid and extending thence along the middle of the lastsouthward named trust-road for a distant of eight chains or thereabouts to a point opposite to the milestone situate on the western side of the same trust-road and indicating a distance of four miles from Halifax and extending thence that is from the last described point in the middle of the said trustroad due eastward and in a direct line for a distance of six chains or thereabouts to a point in the middle of the River Ryburn aforesaid upon the boundary which divides the said parochial chapelry of Saint Peter Sowerby from the new parish of Saint George Sowerby within the original limits of the parish of Halifax aforesaid and extending thence southward along the last described boundary thereby following the course of the said river for a distance of twenty-five and a half chains or thereabouts to the point where the same river is joined by the stream flowing through Highlee Clough and where the said last-described boundary joins the boundary dividing the said parochial chapelry of Saint Peter Sowerby from the district chapelry of Saint Bartholomew Ripponden aforesaid and extending thence south-westward along the last-described boundary thereby continuing to follow the course of the River Ryburn aforesaid for a distance of eight chains or thereabouts to the point where the said river is joined by the stream flowing through Lumb Clough aforesaid at which point the said last-described boundary leaves the same river and extending thence southward from the same boundary along the middle of the said River Ryburn for a further distance of eight and a-half chains or thereabouts to a point at the stepping stones in the same river at the eastern end of Kebroyd-lane and extending thence first north-westward and then south-westward along the middle of the last-named lane for a distance of four chains or thereabouts to a

point at the intersection of the same lane by the Blackstone Edge trust-road aforesaid upon the boundary which divides the said district chapelry of Saint Bartholomew Ripponden from the new parish of Saint Mary Sowerby aforesaid and extending thence northward along the last-mentioned boundary, thereby following the course of the said Blackstone Edge trust-road, for a distance of twelve chains or thereabouts to the first-described point at Kebroyd Bridge aforesaid where the said last-mentioned boundary joins the boundary dividing the said new parish of Saint Mary Sowerby from the parochial chapelry of Saint Peter Sowerby aforesaid at which point the said imaginary line commenced."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Ripon.

HEREAS by an Act passed in the Session of Parliament held in the eighteenth and nineteenth years of Her Majesty's reign, intituled "An Act further to amend the laws concerning "the burial of the dead in England," it is, amongst other things, enacted that it shall be lawful for Her Majesty, by and with the advice of Her Privy Council, from time to time to postpone the time appointed by any Order in Council for the discontinuance of burials, or otherwise to vary any Order in Council made under any of the Acts recited in the said Act, or under the said Act (whether the time thereby appointed for the discontinuance of burials thereunder, or other operation of such Order, shall or shall not have arrived), as to Her Majesty, with such advice as aforesaid, may seem fit:

And whereas Orders in Council have been made directing the discontinuance of burials in the churchyards hereinafter mentioned from the time specified in such Orders; and whereas it seems fit to Her Majesty, by and with the advice of Her Privy Council, that the time for discontinuing burials in the said churchyards be post-

poned:

Now, therefore, Her Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered, that the time for the discontinuance of burials in such churchyards be postponed as follows; viz.:—

In the churchyard of Great Ayton, in the county of York, to the first day of April, one thousand eight hundred and eighty-two.

In the parish churchyard of Newlyn East, in the county of Cornwall, to the thirty-first day of December, one thousand eight hundred and eighty-one.

In the parish churchyard of Nassington, in the county of Northampton, to the first day of January, one thousand eight hundred and eighty-two.
