Board of Health, 10th inst., ordered that arrivals from Aden, shores of Red Sea, and Gulf of Aden south of the 15th degree of latitude, proceeding to an Ottoman port, be required to call at Hodeidah, and submit there or at the Island of Caraman to quarantine. Should vessels from the above-mentioned shores arrive at Jeddah or elsewhere without having performed quarantine they would not be allowed to communicate, but would be driven back to Hodeidah. Warn vessels accordingly.—DUFFERIN."
