PORT OF FOLKESTONE.

LIMITS OF PORT.

WE, the undersigned, Lords Commissioners of Her Majesty's Treasury of the United Kingdom of Great Britain and Ireland, do hereby, under the authority of "The Customs Consolidation Act, 1876," appoint Folkestone on and after the 1st day of January, 1882, to continue and be a Port in that part of the United Kingdom called England, and do hereby declare that the limits of the said Port of Folkestone, shall commence at Copt Point, in the county of Kent, being the western limit of the Port of Dover, and shall extend westwardly along the coast of the county of Kent, and the coast of the county of Sussex, to the point of the headland called Galley Hill, on the coast of Sussex, being the eastward limit of the Port of Newhaven, and shall extend seaward to a distance of three miles from low-water mark, along the coast within the said limits, and shall include all islands, bays, harbours, rivers, and creeks within the aforesaid limits.

And we, the said Lords Commissioners of Her Majesty's Treasury, do hereby, on the day and year above-mentioned, annul all former limits of the Port of Folkestone, and all limits of the Port of Rye, and declare the said Port of Rye to be no longer a Port for Customs purposes.

PORT OF NEWHAVEN.

LIMITS OF PORT.

WE, the undersigned, Lords Commissioners of Her Majesty's Treasury of the United Kingdom of Great Britain and Ireland, do hereby, under the authority of "The Customs Consolidation Act, 1876," appoint Newhaven, on and after the 1st day of January, 1882, to continue and be a Port in that part of the United Kingdom called England, and do hereby declare that the limits of the said Port of Newhaven shall commence at the point of the headland called Galley Hill, on the coast of Sussex, being the western limit of the Port of Folkestone, and shall extend along the coast of the county of Sussex to the north-eastern part of the parish of Rottingdean, in the said county of Sussex, being the eastern limit of the Port of Shoreham, and shall extend seaward to a distance of three miles from low-water mark, along the coast within the said limits, and shall include all islands, bays, harbours, rivers, and creeks within the aforesaid limits.

And we, the said Lords Commissioners of Her Majesty's Treasury, do hereby, on the day and year above mentioned, annul all former limits of the Port of Newhaven.
