and being a person enabled by "The Lands Clauses Consolidation Act, 1845" (Section 7), to sell land, to consent to the conversion of such stock, annuity, or security, into the consolidated stock of the Corporation.

40. To declare any perpetual annuities or other securities, granted or to be granted by the Corporation under any statutory powers, to be

personal estate.

41. To make provision with reference to the exemption from stamp duty of transfers of such consolidated or other stock on such terms and subject to such other payments by way of composition for stamp duty, as may be prescribed or authorised by the intended Act.

42. To enable the Corporation from time to time to make and enforce bye-laws, rules, and regulations for all or any the purposes of the

Bill.

43.
