1. The area described in the Schedule to this Order is hereby declared to be an area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the third day of January, one thousand eight hundred and eighty-two.

An area comprising so much of the Henley petty sessional division, in the county of Oxford, as is bounded by the following roads, but not including such roads,—the road leading from the village of Caversham to Cane End past the Pack Saddle Inn, and from Cane End to Kidmore End, and thence to the village of Caversham.
