THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The area described in the Schedule to this Order is hereby declared to be an area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the fifteenth day of January, one thousand eight hundred and eighty-two.

SCHEDULE.

An area comprising the whole of the parish of Pinchbeck save and except that part known as Cowbit Wash, such part of the parish of Deeping Saint Nicholas as lies in the Parts of Holland, and such parts of the parishes of Cowbit, and Spalding, as lie on the western side of the river Welland, (the whole area being bounded by such river on its eastern side,) in the Elloe division of the Parts of Holland, Lincolnshire.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. This Order shall take effect from and immediately after the thirteenth day of January, one thousand eight hundred and eighty-two.

2. The following area (namely),—the parish of Beswick, in the petty sessional division of North Hunsley Beacon, in the East Riding of the county of York,—which was declared by Order of Council to be an area infected with foot-and-mouth disease, is hereby declared to be free from foot-and-mouth disease, and that area shall, as from the commencement of this Order, cease to be an area infected with foot-and-mouth disease.

3. The following area declared by Order of Council to be an area infected with foot-and-mouth disease (namely),—the parishes of Kilham, Middleton, Rotsea, and Sledmere, in the East Riding of the county of York,—is, except the parishes of Middleton, and Sledmere, hereby declared to be free from foot-and-mouth disease, and that area, except as aforesaid, shall, as from the commencement of this Order, cease to be an area infected with foot-and-mouth disease.

4. The parishes of Middleton, and Sledmere; in the East Riding of the county of York, shall continue to be and are hereby declared to be an area or areas infected with foot-and-mouth disease.
