(No. 11.)-MEDITERRANEAN. FRANCE-SOUTH COAST.

(1.) Port Nouvelle-Alterations in Lights. THE French Government has given notice, that on 15th January, 1882, two lights would be exhibited at the entrance to Port Nouvelle :-

The southern light is a fixed white light, elevated 50 feet above high water, and should be visible in clear weather from a distance of 13 miles.

The lighthouse, 42 feet high, constructed of iron and painted white, is placed at the salient angle of the extended South Pier.

Position, lat. 43° 0' 45" N., long. 3° 4' 0" E.

The northern light is a fixed green light, elevated 33 feet above high water, and should be visible in clear weather from a distance of 4 miles.
