Northampton Tramways (Extensions) Bill.
(Abandonment of Construction of Tramways
(No. 6, 6A, and 6B), authorized by Northampton
Street Tramways Act, 1880; Reduction and
Alteration of Share and Loan Capital; Amend-
ment of Act.)

NOTICE is hereby given, that application is intended forthwith to be made to Parliament by way of petition for additional provision for leave to insert in the Bill now pending in the House of Commons under the above name or short title clauses and amendments for the purposes following, that is to say:

To authorize the Northampton Street Tramways Company to abandon and relinquish the construction of Tramways (No. 6, 6A, and 6B), by the Northampton Street Tramways Act, 1880, authorized to be made, and to release the said Company from all liabilities, penalties, and obligations for or in respect of the non-completion of such Tramways No. 6, 6A, and 6B.

To enable the said Company to reduce and alter the nominal amounts of the share capital and money to be borrowed, which by the said Act of 1880, the Company are authorized to raise and borrow respectively; and to empower the Company to rearrange, reconstitute, consolidate, and regulate the whole of their share and loan capital, with or without preference or priorities and other rights and privileges.

So far as may be requisite for the purposes above-mentioned to alter, amend, or repeal the provisions of the said Northampton Street Tramways Act, 1880.

Walton Vicarage.

(Purchase of the Advowson of the Vicarage of Walton-on-the-Hill, in the county of Lancaster, for the purpose of partially Endowing the See of Liverpool; Extinguishment of Office of Vicar; Transfer of Surplice Fees, Burial Dues, and Vicarage House; Vesting of Vicarage Property in Ecclesiastical Commissioners and application thereof; To make Provision for the Lord Bishop of Liverpool being a Trustee of the Walton-on-the-Hill Rectory Acts; Provisions as to Payment of Costs of Act, and of carrying same into effect; Amendment of the Walton-on-the-Hill Rectory Acts, 1843 and 1877; and other purposes.)

NOTICE is hereby given, that application is intended to be made to Parliament in the present session for leave to bring in a Bill (hereinafter called "the intended Act") for the following, or some of the following, among other purposes (that is to say):—

To amend, extend, and enlarge, or if need be to repeal, all or some of the powers and provisions contained in "The Walton-on-the-Hill Rectory Act, 1843," and "The Walton-on-the-Hill Rectory Amendment Act, 1877."

To confirm and to make provision for carrying into effect an agreement already made or which may be made between the Reverend Richard Leigh, Rector of Walton-on-the-Hill, in the county of Lancaster, Clerk in Holy Orders, and the Trustees appointed by the Committee of the subscribers to a fund collected for the purpose of endowing the

See of Liverpool, called "The Liverpool Bishopric Fund" (hereinafter called "the Trustees"), and to enable the Trustees, with the sanction of the Ecclesiastical Commissioners for England, to purchase, with a portion of the funds so collected, the advowson and perpetual right of presentation of and to the Vicarage of Walton-on-the-Hill aforesaid, in the Diocese of Liverpool, with a view to annexing the revenues of the said Vicarage or a portion thereof to the said See after the next avoidance of the said Vicarage.

To provide that the office of Vicar of Walton-on-the-Hill, and all powers, duties, and obligations attached or belonging thereto or to the Vicar of Walton-on-the-Hill in respect of his vicarage, shall cease and be extinguished as from the next avoidance of the said office, and that from and after such avoidance the Rector of Walton-on-the-Hill shall have sole and entire cure of the souls of the inhabitants of the said parish.

To provide that from and after such next avoidance as aforesaid all surplice fees and burial dues arising within the parish of Walton-on-the-Hill, or the church of the said parish, or such of them as now belong, or would on the next avoidance of the office of Vicar belong, to the Vicar of the said parish, shall belong and be payable to the Rector of the said parish and his successors, and shall form part of the emoluments of the rectory.

To provide that from and after such next avoidance as aforesaid Section 47 of "The Walton-on-the-Hill Rectory Act, 1843," shall be repealed as to the vicarage house and premises adjoining or appurtenant thereto, and that the vicarage house, garden, and premises, now belonging to the Vicar of Walton-on-the-Hill in right of his vicarage, shall be vested in the trustee or trustees for the time being of "The Walton-on-the-Hill Rectory Act, 1843," and be held by him or them on the like trusts and with and subject to the like powers of sale, and other powers, as are therein declared and contained of and concerning the lands and hereditaments vested in and settled on the Trustees therein mentioned, but subject to the proviso that the rents, issues, and profits of the said vicarage house, garden, and premises, or of any hereditaments purchased, or of any other investment made with the proceeds of sale thereof, shall be paid to the rectors for the time being of the parishes of Walton-on-the-Hill and West Derby, and to the Ecclesiastical Commissioners, in equal shares.

To provide that, subject to the provisions of the intended Act, and after the payment of the purchase-money in accordance with the said agreement, all real and personal estate, tithes, income, and emoluments now belonging to and forming part of the property and income of the vicarage of Walton-on-the-Hill, or receivable by the vicar in right thereof, shall, as from the date of the next avoidance of the said vicarage, vest in the Ecclesiastical Commissioners, and that all necessary parties shall execute and do, or concur in executing and doing, all proper deeds, assurances, acts, and things for effectually vesting the same in the said Commissioners.

To provide that the revenues and income so transferred to the said Commissioners shall be applied by them in the first place in payment to the Lord Bishop of Liverpool for the time being of such annual sum as, together with his income from all sources under "The Bishoprics Act 1878," will give him an annual income of four thousand two hundred pounds per annum, exclusive of an episcopal residence, and if and so long as the income of the Bishopric amounts to four thousand two
