

SCOTLAND.—MOVEMENT INTO DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1882.

AT the Council Chamber, Whitehall, the 31st day of March, 1882.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Regulations by Local Authorities in Scotland.

1.—(a.) Notwithstanding anything in The Foot-and-Mouth Disease No. 2 Order of 1881, any Local Authority in Scotland may, with the view of preventing the introduction of foot-and-mouth disease into their district, make regulations for prohibiting or regulating the movement by land or water of animals into their district from the district of any other Local Authority in Scotland:

(b.) Provided, as follows:

- (i.) This Order does not authorize a Local Authority to make a regulation affecting movement of animals into an infected area; and
- (ii.) Any regulation made by a Local Authority under this Order shall not restrict movement of animals by railway through the district of that Local Authority.

Offences.

2. If an animal is moved in contravention of this Order, or of a regulation of a Local Authority thereunder, the owner of the animal, and the person for the time being in charge thereof, and the person causing, directing, or permitting the movement, and the person or company moving or conveying the animal, and the owner and the charterer and the master of the vessel in which it is moved, and the consignee or other person receiving or keeping it, knowing it to have been moved in contravention as aforesaid, shall, each according to and in respect of his or their own acts and defaults, be deemed guilty of an offence against the Act of 1878.

Commencement.

3. This Order shall commence and take effect from and immediately after the first day of April, one thousand eight hundred and eighty-two; and words in this Order have the same meaning as in The Foot-and-Mouth Disease No. 2 Order of 1881.

Short Title.

4. This order may be cited as THE SCOTLAND MOVEMENT INTO DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1882. C. L. Peel.

SCHEDULE.

An area comprising so much of the parish of East Ham, in the county of Essex, as lies within the following boundaries, that is to say, the Romford-road on the north, the London, Tilbury, and Southend railway on the south, Red Post-lane, East Ham, on the east, and Upton-lane, West Ham.

SCHEDULE.

(1.) An area comprising so much of the parish of Great Bowden, in the county of Leicester, as lies within the following boundaries, that is to say, the Leicester turnpike-road on the west, the Union Canal on the north, the road from Harborough to Great Bowden on the east, and thence northwards to the point where the canal crosses the road leading from Great Bowden to the Leicester turnpike, and the northern boundary of the parish of Little Bowden on the south.

(2.) An area comprising so much of the parish of Great Bowden, in the county of Leicester, as lies within the following boundaries, that is to say, the Midland and the London and North-Western railway lines on the east and west, the boundary of the parish of Thorpe Langton on the north, and the road from Great Bowden to Langton on the south.

(3.) An area comprising all lands in the parish of Welham, in the county of Leicester, lying west of the village of Welham and in the occupation of Messrs. Hayres and King.

(4.) An area comprising so much of the parish of Foxton, in the county of Leicester, as lies within the following boundaries, that is to say, the turnpike-road from Harborough to Leicester on the west, the Midland railway line on the north, the road from Bowden Inn to Church Langton on the east, and the road from Leicester turnpike to Langton station on the south.

(5.) An area comprising so much of the parish of Glooston, in the county of Leicester, as lies within the following boundaries, that is to say, Gartree-road on the south, Stouten Wood on the west, two ploughed fields and Bush meadow in the occupation of Mr. Rudkin on the north, and Goadby-road on the east.
