THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The area described in the Schedule to this Order is hereby declared to be an area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the third day of April, one thousand eight hundred and eighty-two.

SCHEDULE.

An area comprising so much of the township of Oldbury, in the county of Worcester, as lies within the following boundaries, that is to say, Newbury-lane as far as the Twin Colliery, from the Twin Colliery by the boundary line of the counties of Worcester and Stafford to the Dudley and Oldbury-road at Brades village, from Brades village by the Dudley and Oldbury-road to Furnace Bridge on the Birmingham and Wolverhampton Canal, and from Furnace Bridge by the Birmingham and Wolverhampton Canal to Newbury-lane aforesaid.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. This Order shall take effect from and immediately after the third day of April, one thousand eight hundred and eighty-two.

2. The limits of the following area which is declared by Order of Council dated the twenty-ninth day of March, one thousand eight hundred and eighty-two, to be an area infected with foot-and-mouth disease (namely),—so much of the parish of Blaston, in the county of Leicester, as lies within the following boundaries, that is to say, the Hallaton railway on the west, Mr. Skeffington's home premises and the highway from Blaston to Slawston on the south, Horninghold-road on the north, and Messrs. Hayn's and Skeffington's ploughed fields and Bordens meadow on the east,—are hereby extended so as to include the area described in the Schedule to this Order, and the area described in the Schedule to this Order is hereby declared to be an area infected with foot-and-mouth disease.

SCHEDULE.

An area comprising the whole of the parish of Blaston, and so much of the parish of Holt as lies on the east side of Blaston and bounded by five ploughed fields in the occupation of Mr. Burton, in the county of Leicester.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. So much of the Order of Council bearing date the twenty-eighth day of March, one thousand eight hundred and eighty-two, as declares certain portions of the parishes of Kilworth, Stanford, Welford, and South Kilworth, to be an area infected with foot-and-mouth disease, is hereby revoked: Provided that nothing herein shall be deemed to invalidate or make unlawful anything done under the said Order before the date of this revocation, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, the said Order.

2. The area described in the Schedule to this Order is hereby declared to be an area infected with foot-and-mouth disease.

An area comprising so much of the parishes of Kilworth, and South Kilworth, in the county of Leicester, and of the parishes of Stanford, and Welford, in the county of Northampton, as lies within the following boundaries, that is to say, certain fields in the occupation of Messrs. Wood and George Gee in the parish of Kilworth, Wood in the parish of Stanford, and Wood, W. Gardiner, Haynes, and John Butlin in the parish of Welford, and W. Hill in the parish of South Kilworth.
